Seven Principles of Healthy Homes

Healthy Homes keeps residents of homes healthier by the following principles:

- **Dry**-Excess moisture creates conditions that affect health
- **Clean**-A clean home help to reduce exposures to pests and contaminants
- **Pest-Free**-Pests can create allergens and be a vector for disease
- **Ventilated**-Fresh air in a home can help with respiratory health
- **Safe**-Children (and older adults) are more prone to injuries in the home that are preventable
- **Contaminant**-Chemical exposures are far greater inside the home and should be avoided such as tobacco smoke
- **Maintained**-Poorly maintained homes are at risk for hazardous conditions like moisture and pests.

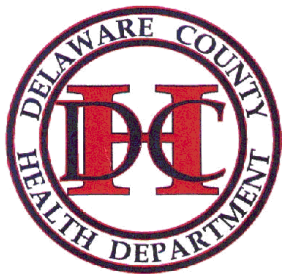
