# COMMITTEE REPORTS

#### Tax Abatements-

Mr. Brad Bookout, Economic Development Alliance, introduced Mr. Steve Kern, CS Kern & Company.

Mr. Kern wanted to inform Council regarding CS Kern & Company abatement. Last year Mr. Kern came before Council requesting the tax abatement. Due to the economy and struggle of getting new business, Kern said the business is down 6%. In the summer of 2014, employees went from 27 to 25. Currently CS Kern is back up to 27 employees. CS Kern has never been on the short end of the tax abatement with City or County Council and this is new territory for Mr. Kern. Mr. Kern assured Council that he doing everything possible to keep his end of the tax abatement.

President Jones said he appreciated Mr. Kern updating Council. Jones said CS Kern & Company is an established company and a member of the community that had fulfilled past obligations. Council realizes Mr. Kern is trying hard to do the right thing. In Jones opinion, this means a great deal. Abatements have been approved by Council and many times to retain jobs.

Councilman Quakenbush said Mr. Kern is not the first generation in the printing business. They have been a part of the community for many years.

Mr. Kern thanked Council.

# Appointments-

Councilman Quakenbush thanked President Jones for coming to him personally about his recent retirement from Civic Center Board and telling him the new board member would need to be a Republican.

<u>MOTION</u>: Councilman Quakenbush nominated Mr. Joe Russell to serve the term of Horizon Center Board, expiring in July 2016.

SECOND: Councilman Spangler

Councilman Alexander asked what the timeline was to get the appointment filled.

Councilman Quakenbush said the appointment should have been filled, since the term expired July 2014.

President Jones said it is a balanced board and a Republican should be appointed to the board. Jones said he made an error in communicating with his own party and certainly Mr. Russell would be a fine member of the committee. Since a motion and seconded was made, a vote will be necessary. President Jones opinion is that the appointment should be debated further, due to others expressing interest.

Councilman Quakenbush said others have had time to come forward regarding interest in the appointment and President Jones came to Quakenbush expressing the fact that it needed to be a balanced board. There was always a policy on balanced boards, even though there was a prevailing majority; there was a respect for the other party that the nomination would come from the party that needed the position on the board. Someone had aggravated a past Council President and (at the time) this changed the tradition. When President Jones showed the respect to Quakenbush he then found someone to nominate.

YEAS; Councilman Quakenbush, Councilman Spangler, Councilman Alexander NAYES; Councilwoman Chambers said she had been contacted by someone so her vote would be no. Councilman Matchett, Councilman Nemyer, President Jones.

Councilman Quakenbush apologized to Mr. Russell and said he had asked in good faith for him to attend the meeting.

President Jones said that was his mistake and apologized.

**Insurance**-President Jones said Commissioners have approved the Anthem contract; however Council had not seen the contract.

Ms. Denise Smith, Recording Secretary, will send Anthem insurance contract to Council.

# Personnel-

President Jones said Ms. Nancy Larson, Human Resource Director, could not attend the meeting and Ms. Pam McCammon, Benefit Specialist, was on vacation. President Jones presented two salary adjustments for approval.

Councilman Quakenbush said 90 day is not an entitlement and it does not have to go in affect at the end of 90 days. Quakenbush suggested making the effective date on the next payroll date.

Ms. Rust said then we would need to go back and pay them.

Councilman Quakenbush said "we don't have to." November 2014 Council meeting Ms. Amanda Dunnuck, Council Attorney, said the ordinance states that it is a 90 day period. If this is not going to be done in the 90 day period then the ordinance would need changed from a 90 days and determined by Council. Currently it is 180 days; there is an increase after 90 days and full pay at 180 days. If Council is not going to honor the 90 and 180 (which is your prerogative), then Council would need to state it in the ordinance. Ms. Dunnuck said it is appropriate to approve the request from the courts with December 4, 2014.

Ms. Rust said to make it less complicated it should be kept on track making it effective as the ordinance states.

# **ORDINANCES**

Ms. Dunnuck presented Ordinance 2014-034A, Establishing Delaware County EMS Capital Improvement Fund. The ordinance needs to be amended due to a one time transfer from capital improvement fund, 1991-60, establishing what that money can be spent for.

Councilman Alexander said the presented ordinance is not on the agenda.

Ms. Dunnuck thought she had sent this ordinance to President Jones and Mr. Jason Rogers.

Copies will be provided.

Ms. Dunnuck said Ordinance 2011-35A essentially had done the same thing allowing a one-time appropriation of funds from EMS Capital Improvement Fund.

Councilman Quakenbush wanted it clarified because Council was not totally clear on how the ordinance was written. The last time Council voted to approve the funding; Quakenbush challenged it and would have challenged it harder if he had realized the line said "a one-time deal."

Ms. Dunnuck said this allows a one-time appropriation.

Councilman Quakenbush said as is it allows Council to break their own rule.

MOTION: Councilman Nemyer motioned to introduce ordinance 2014-034A, Establishing

Delaware County EMS Capital Improvement Fund.

SECOND: Councilman Spangler

Councilman Alexander said it would be nice to have ordinances on the agenda and have a copy provided before the Council meeting.

President Jones said he had received the ordinance from Ms. Dunnuck, however, he thought it was being revised.

Mr. Jason Rogers, EMS Director, said this was discussed during budget hearings. With cuts made for this year's budget, specifically the \$50,000 for overtime....these is no money to pay the employees for their work. It was discussed with Council earlier about paying it from our "own" fund. This overtime is not about..."oh, it is nice to have, it is talking about people's lives at stake. This is the importance of the ordinance."

Councilman Quakenbush said overtime in that department is not because someone is sick. Overtime is part of the regular salary. The appropriation was already approved and the ordinance needs approved to make the appropriation valid.

Ms. Dunnuck said the appropriation had been approved, based on the assumption that a prior ordinance covered it. Upon research, a prior ordinance did not cover it. This ordinance solely accomplishes what Council approved and voted on. Ms. Dunnuck said there is no reason not to suspend the rules. The effective date would be November 25, 2014.

Mr. Rogers said overtime would be due before the end of 2014. It is not just overtime; it also accounts for fuel, oxygen expense and other items.

# MR. MICHAEL SCROGGINS SECURITY

Mr. Michael Scroggins, Sheriff of Delaware County, asked Council to consider giving back the one Security Bailiff that was cut from budget. Scroggins said he drew it out as long as he could (taking security out of the county building.) The \$15,000 part-time monies and two full-time Bailiffs cuts in August forced Mr. Scroggins to provide what is required of him to the Courts. Mr. Scroggins received emails concerning security. Both full-time Bailiffs are not needed but with two full-time Bailiffs, Captain Davis and the \$30,000 part-time money, Scroggins said he could hire part-time Bailiffs and could manage YOC, north security and Justice Center. Mr. Scroggins is asking for a full-time Bailiff, effective January 1, 2015. One Bailiff is retiring (effective November 30, 2014) and one Bailiff is out due to surgery.

President Jones said he attended the Commissioners meeting on Monday, November 24, 2014 and there was concern from the public, employees and Prosecutor. These were valid concerns. Jones asked for any comments from other Council members about security.

Mr. Scroggins said for the record, he was required like other departments to make cuts. After implementing the cuts, Scroggins was asked to rethink about security. Scoggins said he had to work with the numbers Council gave him to work with. Scroggins said both buildings need to be protected but there's only so many resources.

President Jones commended Scroggins for doing a good job.

Councilman Alexander said he understood the safety concern but it is more of how Council is going to get there. Alexander asked that further discussion at the end of the meeting be considered.

Ms. Bailey said they would always come before Council for additional appropriations.

Council supported this.

President Jones said interest on Tax Anticipation warrant loan was \$20,473.97. Ms. Patterson was going to suggest that this be taken from another fund but after discussion it will be taken from lease rental fund. No action is needed.

Ms. Lackey is concerned about payment for Stormwater and does not know anything regarding this. There was a lengthy discussion between Council, Ms. Lackey and Ms. Bicknell. It was

determined that nothing could be done at the meeting, due to it not being advertised. This will be brought up at December Council meeting.

# AMERESCO UPDATE

Mr. Rick Lorrison, Justice Center Maintenance, said a Common Wage Hearing was held November 21, 2014, to set the wages for the project. Contracts have been sent to contractors. Lighting on the outside of county building and Justice Center will start after Thanksgiving. Installation of seven poles with LAD lighting to brighten up the plaza and four will be installed in front of county building. Chillers will be up and running by mid-March 2015. The current chillers are shut down.

# **HEALTH DEPARTMENT CLAIM**

Mr. Jammie Bane, Health Department Administrator, updated Council regarding the Workers Comp claim due November 27, 2014. Mr. Bane is new to the Health department and does not have a lot of knowledge of the \$69,380.77 claim; however, he is receiving the bills. Human Resources has dealt with it through CMI (Workers Comp Insurance Company).

President Jones said he realized this issue was inherited but Jones has questions for Human Resources.

Mr. Bane said attorney fees still will be billed to the county.

President Jones asked if any Workers Comp claims had been contested and what the outcome was.

Ms. Lackey said details cannot be publically reviewed, due to legal issues.

Ms. Dunnuck said from a procedural standpoint it was resolved. If there was an agreement entered into with the insurance company and the employees' attorney then that can be reduced to a judgment, which is handled different from no judgment. The judgment is a court order which allows finding monies in different places. This information is needed so Council can figure how they are going to deal with it.

Councilman Quakenbush asked Mr. Bane if he had the money from his budget to pay the bill.

Mr. Bane said no.

Ms. Dunnuck wondered when Workers Comp claims started coming out of individual budget.

Ms. Lackey said when the Commissioners budget could not handle them any longer. Departments are more concerned also if they have to pay from their budget.

Ms. Rust said paying Workers Comp through departments came from the Commissioner's office.

Councilman Alexander requested a summary from Human Resources rather than speculate on what took place.

November 2014 Council meeting

President Jones said Council should not be approving or appropriating monies for claims that Council had no idea about.

Ms. Dunnuck said Council will not receive paperwork on the claim. Council is not entitled to any information.

Councilman Quakenbush said county general was paying liability insurance and it should not have been. Departments that have a separate tax rate should be paying. We are paying for something that we cannot afford.

Mr. Bane said there is a \$200,000 deductible on each claim. Two of those would account for the entire staff of Health department. Bane said this seems to be a flawed system with that big of a deductible and no money.

President Jones said he knew the case was being discussed and litigated but just became aware of the resolution. The bill will not be paid today, (November 25, 2014) because we cannot.

Ms. Lackey said there will be a penalty if the bill is not paid on time. The bill was dated November 21 and due November 27. This is something that all of sudden appeared. This event has been ongoing for two years.

Ms. Dunnuck said she had never seen a payment due two days later.

Mr. Bane received an email that was sent to Ms. Nancy Larson and that Ms. Pam McCammon forwarded. The county, per Ms. Larson, uses another law firm from Indianapolis, IN to deal with issues such as this. The settlement was 65% of the bill.

Councilman Quakenbush asked that Ms. Dunnuck contact the Commissioners attorney and speak with CMI. If it is a judgment it does not have to be appropriated.

Ms. Dunnuck will speak with Mr. Steve Murphy, County Attorney. Mr. Bane should forward the invoice to Ms. Dunnuck.

Ms. Larson came to the meeting after Ms. Lackey called her regarding questions.

Councilman Alexander explained to Ms. Larson that they were in discussion regarding a claim that is due and payable within 5 days of receipt.

Ms. Nancy Larson, Human Resource Director, said it was just settled at 65% instead of 100% of the bill. This has been ongoing since March 2014. It was a bill that was coming and is less than what is was going to be. Ms. Larson said this was settled out of court. This will be paid to CMI and they pay the hospital. The employee settled but this is separate from the medical bill. CMI set the deadline of the invoice. It was supposed to be paid within 30 days of settlement. Settlement was in March 2014.

Ms. Dunnuck asked why settlement is coming up now and why not before. How are "you" negotiating that settlement?

Ms. Larson said it was separate negotiation.

Ms. Dunnuck said what is due now is obviously not settled in March 2014, right?

Ms. Larson provided the contract.

Ms. Dunnuck said she is unable to read the entire contract at Council meeting. Ms. Dunnuck does not want to call apposing Council but she will call Mr. Murphy.

President Jones said this matter will be investigated, but will not be paid today. Jones asked if it was Ms. Dunnucks' intent to contact Council soon.

10:40 a.m.

Ms. Dunnuck said yes.

Councilman Alexander said if this has to be paid to avoid further penalties, what action today would we need to take authorizing the Auditor...

Ms. Dunnuck said by law we cannot appropriate new money without advertising it for 10 days, we cannot spend money without being appropriated unless it is reduced to a judgment. Whoever entered into the 6 day payment window, it cannot be accomplished and is not reasonable.

10:41 a.m.

Ms. Larson said her understanding is in March 2014 is when it was settled with the employee and with the medical bills. At that time, "we" were trying to reduce the medical bill and that is what has been waiting up to this point. The employee has been compensated.

Ms. Dunnuck said it is not settled until it is settled....if it was recently just agreed upon on the amount then there is no way it could have been paid in March when it was not known. Ms. Dunnuck will make some calls and update Council.

President Jones said he would include Ms. Larson and Mr. Banes and then will communicate with Council. He will keep the Auditor's office involved.

Councilman Quakenbush said even with an Emergency meeting, the deadline could not be reached.

Ms. Larson said "we" argued with them also.

Ms. Dunnuck said is this the only remaining bill.

Ms. Larson said "for this employee, yes."

November 2014 Council meeting

Ms. Larson said yes, for this employee. Ms. Larson said the attorney fees have not been paid. Ms. Larson said she worked hard to get this accomplished and only gets bits and pieces. If Council wants an attorney to represent this because Larson said she is not sure she is the right person to do this.

Ms. Dunnuck said she will not read the names and information in the contract.

President Jones agreed.

Councilman Alexander asked where the charge is for this bill. Alexander said someone had to make the agreement for Delaware County.

Ms. Dunnuck was asking those questions and Ms. Larson walked out. Ms. Dunnuck will make phone calls to legal Counsel.

# **COUNCIL MEETINGS 2015**

Ms. Denise Smith, Recording Secretary, will advertise Council 2015 Reorganizational meeting immediately following Commissioners meeting.

Ms. Smith asked about 2015 Council meeting.

Councilman Quakenbush said it was his greatest disappointed since he has been on Council regarding Civic Center Board member. This appointment has been open for three months.

Councilman Alexander asked if maybe Mr. Joe Russell would be a transitional position.

President Jones said that is not appropriate. Jones said he understood and appreciated Quakenbush and his comments.
