ABANDONMENT OF INTEREST AND RIGHTS AND REESTABLISHMENT OF PORTIONS OF LIMITED ACCESS CONTROL LINE AND CONSENT THERETO BY ABUTTING PROPERTY OWNER

BY ORDER OF THE CHIEF ENGINEER FOR HIGHWAY OPERATIONS:

- WHEREAS, the Indiana Code § 8-23-4-9 authorizes the abandonment of surplus right-of-way by the Indiana Department of Transportation; and
- WHEREAS, IC § 8-23-2-6 authorizes the Commissioner or the Commissioner's designee to abandon and dispose of property and to execute all instruments to carry out the responsibilities of the department; and
- WHEREAS, the Commissioner has, by an Order dated June 16, 2000, designated and delegated to the Chief Engineer of the Indiana Department of Transportation, the authority to execute all instruments to release and abandon property easements and rights which were originally acquired for highway purposes; and
- WHEREAS, a certain Limited Access Control Line ("LA Line") was acquired for the construction of a future interchange in conjunction with the construction of SR 332, Project ST-4218(C), Code 1928, affecting three (3) parcels of land; two (2) in the southeast quadrant of SR 332 and Delaware County Road 600W, said parcels as described in Deed Record Book 1973 Page 717 and Deed Record Book 1974 Page 4913; and one (1) in the northwest quadrant of SR 332 and Delaware County Road 600 W, said parcel described in Deed Record Book 1976 Pages 361 -4, said parcels all owned by the Delaware Board of County Commissioners and all located in Delaware County, Indiana; and
- WHEREAS, the LA Line, as presently located, will not be needed for highway purposes incidental thereto, now or within a reasonable time in the future, and the LA Line may be moved and reestablished to certain points closer to SR 332; and

- WHEREAS, the Delaware Board of County Commissioners are the sole owners of said property affected by the said LA Line, and has requested that the LA Line be abandoned and vacated, and reestablished closer to SR-332, a request with which the Indiana Department of Transportation concurs; and
- WHEREAS, the portions of the LA Line being abandoned and vacated herein are depicted on the two (2) plats marked Exhibit A and attached hereto, and more fully described in the two (2) corresponding legal descriptions marked Exhibit B and attached hereto; and
- WHEREAS, the Limited Access Control Line shall be located as depicted on the plats marked Exhibit A as attached, and more fully described in the legal descriptions marked Exhibit B and attached hereto;

NOW, THEREFORE, I MARK A MILLER, P.E., CHIEF ENGINEER OF THE INDIANA DEPARTMENT OF TRANSPORTATION, by virtue of the authority vested in me by the Order of the Commissioner to act in his behalf as authorized by I.C. § 8-23-2-6, do hereby determine that the above-referenced portions of the LA Line are **EXCESS** and are not needed for highway purposes or purposes incidental thereto now or within a reasonable time in the future; that said portions of the LA Line be, and the same are hereby **ABANDONED** as authorized by I.C. § 8-23-4-9 and as described in the two (2) plats marked Exhibit A and attached hereto, and more fully described in the two (2) corresponding legal descriptions marked Exhibit B and attached hereto, and that a new Limited Access Control Line be, and the same is hereby, **REESTABLISHED** also shown and described on the Exhibits.
