

ORDINANCE NO. 2011 - 041

ORDINANCE TO ENACT COMMISSIONER DISTRICTS  
AND TO AMEND ORDINANCE 2002-001

An ordinance amending Title 1, Chapter 4, Section 1 of the Delaware County Code is to be amended as follows.

WHEREAS, Indiana requires each County of Indiana to reestablish voter precincts; and

WHEREAS, Delaware County Indiana, by and through its Board of County Commissioners has conducted a study to determine proper County Commissioner Districts as affected by Indiana Law.

NOW THEREFORE, be it ordained by the Commissioners of Delaware County, as follows:

1. AMENDMENTS

A. Title 1, Chapter 4, Section 1, which now reads:

The County of Delaware is divided into three (3) County Commissioner Election Districts designated numerically as follows:

District #1 - 7, 11, 12, 18, 28, 29, 35, 39, 41, 43, 46, 48, 60, 61, 63, 64, 65, 66, 67, 69, 75, 77, 90

District #2 - 1, 2, 4, 6, 8, 9, 13, 14, 15, 19, 20, 22, 23, 25, 27, 40, 44, 45, 47, 49, 56, 57, 70, 78, 92, 93

District #3 - 3, 10, 26, 33, 34, 36, 38, 50, 51, 52, 53, 54, 55, 59, 62, 68, 71, 73, 74, 81, 87, 88, 94, 95, 97, 98

Shall be stricken and amended as follows:

District #1 includes precincts – 1, 5, 6, 9, 13, 14, 15, 19, 20, 22, 23, 25, 33, 44, 51, 52, 53, 54, 59, 71, 73, 81, 94

District #2 includes precincts – 3, 4, 8, 10, 26, 27, 34, 36, 38, 40, 42, 45, 47, 49, 50, 55, 56, 57, 58, 70, 74, 78, 87, 88, 95, 98,

District #3 includes precincts – 2, 7, 11, 12, 18, 28, 29, 35, 39, 41, 43, 46, 48, 60, 61, 62, 63, 64, 65, 66, 67, 68, 69, 75, 77, 90, 91, 92, 93

2. Repealer

A. All ordinances or parts of ordinances in conflict with provisions of this ordinance are hereby repealed.

3. Severability Clause






