AN ORDINANCE TO AMEND AN ORDINANCE REGULATING TRAFFIC ON CERTAIN PUBLIC STREETS IN DELAWARE COUNTY

BE IT ORDAINED: By the Board of County Commissioners, Delaware County, Indiana that an ordinance enacted prior to this day, , 2012, entitled "Traffic Ordinance" is hereby amended as follows:

Title 5, Chapter 4, Section 8, is to be amended as follows:

- Item No. 1. There shall be a 50 mph speed limit on County Road 200 South, between Andrews Road and Proctor Road, located in Mt. Pleasant Township, Delaware County, Indiana.
- Item No. 2. There shall be a 40 mph speed limit on Whitney Road, between E. Jackson Street and Inlow Springs Road, located in Liberty Township, Delaware County, Indiana.
- Item No. 3. There shall be a 45 mph speed limit on County Road 400 East, between Centennial Avenue and County Road 550 North, located in Liberty and Delaware Townships, Delaware County, Indiana.
- Item No. 4. There shall be a 30 mph speed limit on Truitt Road, between E. Jackson Street and Centennial Avenue, located in Liberty Township, Delaware County, Indiana.
- Item No. 5. There shall be a 40 mph speed limit on County Road 800 North, between Old Granville Road and County Road 200 East, located in Niles and Union Townships, Delaware County, Indiana.
- Item No. 6. There shall be a 45 mph speed limit on County Road 800 North, between IN 3 and Wheeling Avenue, located in Union and Washington Townships, Delaware County, Indiana.
- Item No. 7. There shall be a 40 mph speed limit on County Road 500 North, between IN 67 and County Road 400 East, located in Delaware Township, Delaware County, Indiana.
- Item No. 8. There shall be a 45 mph speed limit on Clifton Road, between County Road 400 East and County Road 550 East, located in Delaware Township, Delaware County, Indiana.
- Item No. 9. There shall be a 50 mph speed limit on County Road 500 North, between County Road 550 East and County Road 900 East, located in Delaware Township, Delaware County, Indiana.

- Item No. 10. There shall be a 40 mph speed limit on Royerton Road, also known as, County Road 500 North, between Walnut Street and Wheeling Avenue, located in Hamilton Township, Delaware County, Indiana.
- Item No. 11. There shall be a 50 mph speed limit on County Road 500 North, between County Road 600 West and County Road 900 West, located in Harrison Township, Delaware County, Indiana.
- Item No. 12. There shall be a 45 mph speed limit on County Road 700 East, between Centennial Avenue and County Road 500 South, located in Liberty and Perry Townships, Delaware County, Indiana.
- Item No. 13. There shall be a 50 mph speed limit on County Road 700 East, between County Road 500 South and County Road 800 South, located in Perry Township, Delaware County, Indiana.
- Item No. 14. There shall be a 50 mph speed limit on Centennial Avenue, between County Road 650 East and the Delaware County / Randolph County line, located in Liberty Township, Delaware County, Indiana.
- Item No. 15. There shall be a 50 mph speed limit on County Road 800 East, between Edgewater Road and E. Jackson Street, located in Liberty and Delaware Townships, Delaware County, Indiana.
- Item No. 16. There shall be a 45 mph speed limit on County Road 800 East, between E. Jackson Street and County Road 125 South, located in Liberty Township, Delaware County, Indiana.
- Item No. 17. There shall be a 45 mph speed limit on County Road 800 East, between Stanley Road and County Road 450 South, located in Liberty and Perry Townships, Delaware County, Indiana.
- Item No. 18. There shall be a 50 mph speed limit on County Road 800 East, between County Road 450 South and County Road 700 South, located in Perry Township, Delaware County, Indiana.
- Item No. 19. There shall be a 50 mph speed limit on Langdon Road, between Bethel Avenue and IN 28/35, located in Harrison Township, Delaware County, Indiana.
- Item No. 20. There shall be a 45 mph speed limit on Langdon Road, between IN 28/35 and McCreery Road, located in Harrison Township, Delaware County, Indiana.
- Item No. 21. There shall be a 40 mph speed limit on County Road 750 West, between McCreery Road and County Road 850 North, located in Harrison and Washington Townships, Delaware County, Indiana.

Item No. 22. There shall be a 45 mph speed limit on County Road 850 North, between Gaston limits and County Road 900 West, located in Washington Township, Delaware County, Indiana.

Item No. 23. The County Highway Department of Delaware County, Indiana, is hereby authorized to erect appropriate signage pursuant to the Indiana Manual on Uniform Traffic Control Devices.

Item No. 24. The penalty for violation of this ordinance shall be as herein setforth in Article XVI, Section 16-1.

Item No. 25. This ordinance shall be in full force and effect from and after its passage and publication.
