DECISION OF THE DELAWARE COUNTY COMMISSIONERS

COME now the Delaware County Commissioners and pursuant to Article 11, section 11.7, step 3 of the Collective Bargaining Agreement with the UAW dated September and extended through September 2017 with the 911 Center Employees and the grievance filed by Julie Cline hereby makes the following filings:

- On July 2, 2016 Director Joseph Winkle was provided an e-mail from Mike Ashley concerning calls handled by Julie Cline. Joseph Winkle is the Director of the 911 Center and the Supervisor of all the employees.
- Director Winkle then submitted the matter to Supervisor Patrick Richmond on July 7, 2016 for investigation.
 On July 8, 2016 Supervisor Richmond requested a three day extension of time
- On July 8, 2016 Supervisor Richmond requested a three day extension of time
 of Chairman Christopher King without informing Chairman King that the
 original complaint had been presented to the Executive Director on July 2,
 2016.
- 4. Article 10, Section 10.4 requires that discipline be administered within seven (7) days after the offense had become known to their supervisor.
- days after the offense had become known to their supervisor.5. Seven days after the offense had been known to the Supervisor would have been July 9, 2016.
- Executive Director Winkle administered discipline, that being termination of Julie Cline, on July 15, 2016. At the time of termination, Director Winkle had two other calls that were handled by Julie Cline and chose not to administer disciplinary action on those calls.
- Prior disciplinary precedent for mishandling calls has resulted in disciplinary action less than termination for other employees.
- 8. The discipline was not provided in a timely manner as per the contract.
- Director Winkle failed to provide any information, evidence, or argument at the grievance hearing with the Commissioners and actually walked out of the hearing.

- Executive Director Winkle refused to participate in the grievance hearing in front of the Commissioners.
- 11. The County Commissioners were limited in the information provided to them concerning the grievance as to the facts and circumstances provided by the grievant only.
- 12. There may have in fact been facts and information which Director Winkle had which was pertinent to the grievance, but Director Winkle chose to not participate and ignore the process.
- 13. There was evidence that Julie Cline was inadequately trained and needs additional training on handling calls and performing her job duties at the 911 center.
- 14. Had Julie Cline been adequately and properly trained then the issue may not have arisen.

It is therefore the determination of the Board of County Commissioners in response to Article 11, section 11.7, Step three of the grievance process that Julie Cline;

- 1. Be immediately reinstated to her position as communication technician
- That she be assigned to midnights
- 3. That she be awarded back pay in the sum of \$7,721 of gross pay from the date of termination.1
- 4. That this matter be removed from her employee file.
- 5. That Julie Cline be provided additional training of at least 40 hours to correct any issues.





UNDERGROUND FACILITIES LOCATING AND MARKING SERVICE AGREEMENT

THIS CONTRACT is entered into as of September 26, 2016, and is by and between USIC Locating Services, LLC, an Indiana limited liability company, (USIC), and Delaware County Government Center (Customer).

BACKGROUND

- A. Customer owns and operates underground facilities in the geographic area described on Attachment A to this Agreement (Contract Service Area).
- B. Customer desires to have USIC provide the necessary labor and equipment to provide certain services relative to locating and marking Customer's underground facilities in the Contract Service Area.

AGREEMENT

Based on the Background set forth above and in consideration of the mutual covenants, terms and conditions set forth below, USIC and Customer agree as follows:

- <u>Definitions</u>. In addition to the terms defined above the following capitalized terms when used in this Agreement shall have the following meanings:
 - 1.1 After Hours Call Out means locate requests made on USIC-observed holidays (Memorial Day, Independence Day/July 4th, Labor Day, Thanksgiving, Christmas, and New Year's Day), weekends, and weekdays from 5 p.m. to 7 a.m., or any time outside of the applicable state one-call's regular business hours.
 - 1.2 APWA means the American Public Works Association and its Underground Utility Location and Coordination Council.

LOCAL ROADS AND BRIDGES MATCHING GRANT AGREEMENT EDS # A249-

This Local Roads and Bridges Matching Grant Agreement (this "Grant Agreement"), is made and entered into effective as of the date of the Indiana Attorney General signature affixed to this Agreement by and between the Indiana Department of Transportation (hereinafter referred to as the "State") and <u>Delaware County</u>, a Local Unit, (hereinafter referred to as the "Grantee"), and collectively referred to as the Parties, is executed pursuant to the terms and conditions set forth herein. In consideration of those mutual undertakings and covenants, the Parties agree as follows:

RECITALS

Whereas, Ind. Code § 8-23-30 establishes the Local Road and Bridge Matching Grant Fund, one purpose of which is to enable the State to make matching grants to Local Units for Eligible Projects; and

Whereas, the Grantee uses an approved transportation asset plan on file with the State; and

Whereas, the Grantee is a Local Unit as defined in Ind. Code § 8-23-30-1 and is eligible to receive a grant; and

Whereas, the Grantee has submitted an application for an Eligible Project as defined in Ind. Code § 8-23-30-1 (the "Project") and described in Attachment A, attached and incorporated by reference to this Grant Agreement; and

Whereas, the Grantee has committed matching funds from one of the following revenue sources in accordance with Ind. Code § 8-23-30-3: (1) increased local motor vehicle excise surtax or wheel tax under Ind. Code § 6-3.5; (2) special distribution of local income tax under Ind. Code § 6-3.6-9-17; or (3) local rainy day fund under Ind. Code § 36-1-8-5.1; and

Whereas, the State has chosen to fund the Grantee's Project in accordance with the terms of this Grant Agreement; and

Whereas, the Grantee desires to expedite delivery of the Project, comply with all State requirements and fiscally manage the Project; and

Now Therefore, in consideration of the mutual covenants and promises herein contained, the Grantee and the State agree as follows:

The "Recitals" above are hereby made an integral part and specifically incorporated into this Grant Agreement.

1. Purpose of this Grant Agreement; Grant Funds.

The purpose of this Grant Agreement is to enable the State to award a grant to the Grantee, representing 50% of the eligible costs of the Project described in Attachment A of this Grant Agreement, which is incorporated fully by reference. The funds shall be used exclusively in accordance with the provisions contained in this Grant Agreement and in conformance with Ind. Code § 8-23-30 establishing the authority to make this Grant, as well as any program requirements as identified by the State. The funds received by the Grantee pursuant to this Grant Agreement shall be used only to implement the Project in conformance with this Grant Agreement and for no other purpose.
