CONFINED ANIMAL FEEDING OPERATION (CAFO)

President King said a public meeting will be held for discussion purposes about the proposed Confined Animal Feeding Operation (CAFO). The meeting will be held at Heartland Hall, located at the Delaware County Fairgrounds on March 8, 2018 at 6:00 p.m.

The proposed location for the CAFO facility is 2601 West County Road 1270-North in Union Township.

Ms. Marta Moody, Plan Commission Director, said the requirement for notification is ½ mile (2600 ft.).

Ms. Fant said it would be very beneficial for the county to gain access to the available resources. Ms. Fant introduced Ms. Heather Williams. Williams has been working with Muncie Action Plan and Ball State University for five years building Neighborhood Associations.

Mr. Harry Evans, thanked the Commissioners for setting the CAFO meeting. Mr. Evans said they are on a time sensitive matter through IDEM. Mr. Evans asked for a moratorium so that no one regarding the CAFO can ask for a permit.

Ms. Moody and Mr. Brooke questioned rather a moratorium could be done the same day as the request. They both agreed that the terms would need to be laid out regarding the moratorium beforehand.

President King said a Special Meeting may be considered, due to the timeframe.

Commissioner Henry asked that the Building Commissioner not issue any building permits regarding CAFO's until the Commissioners can look into this further.
