**NOTICE TO INTERESTED PERSON OF PETITION FOR APPOINTMENT

A hearing will be held on _____ at _____ o'clock ___m in the court referenced in the above, caption, to determine whether the Court should appoint a guardian for _____. The purpose of this proceeding is to protect said person. You are entitled to attend this hearing, file motions, and if the court allows, provide testimony. A copy of the petition requesting appointment of a guardian is attached to this notice. At the hearing the court will determine whether said person is an incapacitated person or minor under Indiana law. If the Court finds that said person is an incapacitated person or minor, the Court at the hearing shall also consider whether Petitioner, _____ should be appointed as guardian of said person. The Court may, in its discretion, appoint some other qualified person as guardian. The Court may also, in its discretion, limit the powers and duties of the guardian to allow said person to retain control over certain property and activities. The Court may also determine whether a protective order should be entered on behalf of said person. Said person may attend the hearing and be represented by an attorney. The petition may be heard and determined in the absence of said person if the Court determines that the presence of said person is not required. If said person attends the hearing, opposes the petition, and is not represented by an attorney, the Court may appoint an attorney to represent the alleged incapacitated person or minor. The Court may, where required, appoint a guardian ad litem to represent said person at the hearing. The Court may, on its own motion or on request of any interested person, postpone the hearing to another date and time.

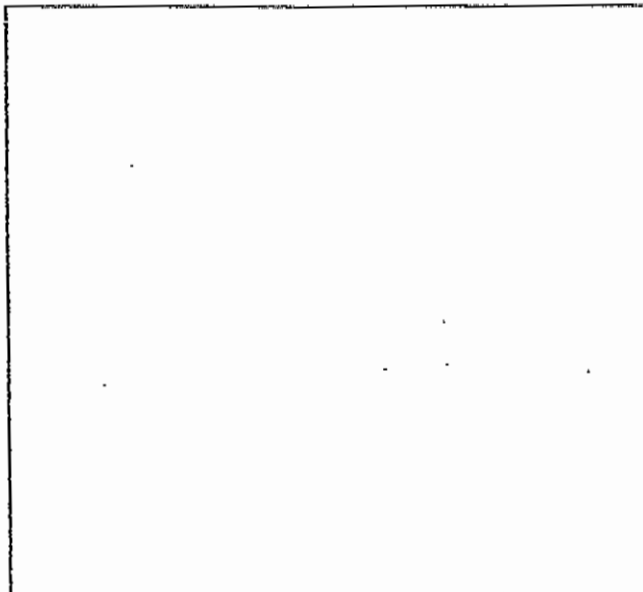
