- 1. Submit claim/invoice to DCRC by 12:00 p.m. on the 1st Friday of the month
 - a. Send to Danyel Struble at dstruble@bslawgroup.com
- 2. DCRC Board Members meet and approve claims at regular meetings on the 2nd Thursday of each month
- 3. Once DCRC approves the claim, a Delaware County claim form is prepared by DCRC and presented to the Delaware County Commissioners for Approval and paid by the Delaware County Auditor consistent with the following schedule:
