#### RESOLUTION 25-51

**WHEREAS**, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

**WHEREAS**, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

**WHEREAS**, the proposed modification to the FY 2026-2030 DMTIP to increase INDOT Project DES #2201151, From I-69 to 3.76 mile W of Sr 3 (CR 400 S) (Traffic signal modernization), FY 2026 PE from \$26,000 to \$31,000 federal HSIP funds for an increase of \$5,000 was requested by INDOT; and


**WHEREAS**, INDOT Project Des #2201151 was submitted to the Interagency Conformity Group (ICG) for confirmation of exempt status with an exempt status concurrence date of March 25, 2025.

**WHEREAS**, the proposed modification above was approved and processed by the Muncie-Delaware Metropolitan Plan Commission (DMMPC) Muncie MPO on November 10, 2025.

**NOW, THEREFORE, BE IT RESOLVED** by the Transportation Policy Committee of the DMMPC as follows:

**Section 1.** That the FY 2026-2030 DMTIP be modified to increase INDOT Project DES #2201151, From I-69 to 3.76 mile W of Sr 3 (CR 400 S) (Traffic signal modernization FY 2026 PE from \$26,000 to \$31,000 federal HSIP funds for an increase of \$5,000 as shown on the attached Exhibit A.
