PROSECUTOR CHARGES MYRON ARMSTRONG WITH MURDER

Muncie Indiana – On today's date the Prosecuting Attorney Eric M. Hoffman formally charged Myron J. Armstrong (DOB 5/12/1994) with the following criminal offenses:

Count 1: Murder, a felony

The charges are pending in the Delaware Circuit Court No. 5. The Honorable Judge Thomas A. Cannon Jr. has will set the matter for an initial hearing. Copies of the charging information and Affidavit of Probable Cause that were filed with the Court are attached. The Court has ordered that the defendant be held in custody without bail.

Pursuant to Indiana law:

 Murder is punishable by 45 – 65 years in prison and up to a \$10,000 fine.

It is important to remember that any accusation that someone has committed a crime, an arrest and/or the filing of a criminal charge is simply an allegation and is not evidence of guilt. All suspects are presumed innocent unless and until proven guilty beyond a reasonable doubt at trial. The ethical rules for prosecutors in Indiana prohibit further comment on this matter. At this time, there will be no further comment.
