### JURY CONVICTS THOMAS BEALL OF MULTIPLE COUNTS OF CHILD MOLESTING

Muncie Indiana – Today a Delaware County jury deliberated for approximately 2

hours before convicting Thomas L. Beall (DOB 1/5/1985)

of:

Count 1: Child Molesting, a Level 1 Felony
Count 2: Child Molesting, a Level 1 Felony
Count 4: Child Molesting, a Level 1 Felony
Count 5: Child Molesting, a Level 4 Felony
Count 6: Child Molesting, a Level 4 Felony

A copy of the Affidavit of Probable Cause for Arrest is attached. The Honorable Marianne L. Vorhees, Judge of the Delaware Circuit Court No. 1 set sentencing for November 16, 2022 at 9:00 AM. Pursuant to Indiana law:

- Each Level 1 Felony is punishable by 20 50 years in prison and up to a \$10,000 fine.
- Each Level 4 Felony is punishable by 2 12 years in prison and up to a \$10,000 fine.

After the verdict was returned, Delaware County Prosecuting Attorney Eric Hoffman said "the Defendant in this case is nothing but a child predator has been finally held accountable for his heinous crimes.
