

CONTRACTS OR AGREEMENTS FOR APPROVAL APEX BENEFITS RENEWAL

Ms. Pam McCammon, Human Resource Director, presented APEX Benefits Renewal for 2023. Ms. McCammon thanked Mr. John Brooke, Attorney for Delaware County and Ms. Ginger Brown, Human Resource Assistance for their help.

Ms. McCammon said several vendors were contacted regarding quotes, however, GPA, Apex is still providing the best rates saving Delaware County money.

An HRA account was added in 2022 for employees. The deductible has gone up to \$5000 out of pocket and then paid out at 100%. The Commissioners will only pay the \$1000 difference for each employee.

Last year the prescription company was changed to TRUErx, saving \$163,000 for Delaware County. The vision, Delta Dental, One American Life Insurance, Voluntary Life, short term and long term will remain the same until 2024.

The increase will be 3.5%, however, without hesitation the Commissioners are picking up the increase for employees.

Commissioner Henry agreed that Apex is probably the best and did not want to take the 5% raise from employees. All Commissioners felt the same way as Commissioner Henry.

AGREEMENT FOR SERVICES

This Agreement for Services (the "Agreement"), executed as of October 11, 2022, (the "Effective Date "), by and between Commissioners of Delaware County, Indiana ("County"), and Delaware County Justice Partners, LLC, an Indiana limited liability company ("Service Provider").

RECITALS

WHEREAS, County has selected Scrvice Provider in connection with a project to develop, design, build and finance the County's mental health and rehabilitation center (the "Project");

WHEREAS, County and Service Provider have not yet entered into a project agreement in connection with the Project (a "BOT Agreement");

WHEREAS, as an accommodation to County in order to meet the proposed timeline for the Project, County has requested that Service Provider commence preliminary services prior to completion and execution of the BOT Agreement, and County has agreed to compensate Service Provider for such Services as set forth herein in the event that the Project does not progress to the point where a BOT Agreement would be appropriate;

WHEREAS, Service Provider has experience in providing the Services; and

WHEREAS, County and Service Provider desire to enter into this Agreement to formalize the terms and conditions upon which Service Provider shall perform the Services;

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged hereby, County and Service Provider agree as follows:

1. Services. Subject to the terms and conditions of this Agreement, Service Provider shall perform the Services described in Exhibit A (the "Services"). Service Provider shall be an independent contractor of County. The term of this Agreement shall be for the period: (a) commencing on the Effective Date; and (b) ending on the earlier of executing a formal BOT Agreement or 130 days (the "Outside Date"), unless earlier terminated in accordance with the terms and conditions of this Agreement.

2. Payment.

a. The Service Provider will perform the BOT Agreement Assembly Phase services described in Exhibit A to create plans at a level of detail sufficient to allow the Service Provider to obtain a Guaranteed Maximum Price bid. If, prior to the Outside Date, the Service Provider successfully produces plans meeting the approved scope and budget and a BOT Agreement is executed to cover final design and construction services, all compensation for the Services performed under this Agreement shall be included in the BOT Agreement. In the event a formal BOT Agreement is not executed by the Outside Date, as compensation in full for the Services, County shall pay Service Provider for Services completed at the time of termination a lump-sum fee of \$75,000.

3. Performance. Service Provider shall perform the Services: (a) in coordination with County; (b) in accordance with the prevailing professional standards in the Delaware County, Indiana, area for similar services; and (c) in compliance with applicable laws, statutes, and/or ordinances, and any applicable governmental rules, regulations, guidelines, orders, and/or decrees (collectively, the "Laws"). Prior to commencing the Services, Service Provider shall: (a) obtain all permits and approvals required by the Laws; and (b) obtain and maintain during performance of the Services, all professional licenses and certifications required by the Laws. Service Provider shall provide to County, upon request, copies of any and all such

AN ORDINANCE TO AMEND AN ORDINANCE REGULATING TRAFFIC ON CERTAIN PUBLIC STREETS IN DELAWARE COUNTY

WHEREAS, the Board of Commissioners are charged with protecting the health and welfare of the citizens of Delaware County; and

WHEREAS, the Board of Commissioners are obligated to review and, if necessary, amend the Street and Road Regulations of the County Highway System to allow for the more orderly and safe mode of travel on the roads; and

WHEREAS, the Board of Commissioners conducted a public hearing on October 17, 2022 with respect to a number of all way stops and speed limit changes; and

WHEREAS, the Board of Commissioners determine that certain changes will be necessary to the Delaware County Code, Title 5, Chapter 4, Street and Traffic Regulations.

THEREFORE, BE IT ORDAINED: By the Board of County Commissioners, Delaware County, Indiana that Delaware County Code, Title 5, Chapter 4, Street and Road Regulations shall be amended as setforth herein:

- 1. Title 5, Chapter 4, Section 5, is to be amended as follows:
 - A. There shall be an all way stop at the intersection of CR 800E and Centennial Ave. located in Liberty Township, Delaware County, Indiana for
 - B. There shall be an all way stop at the intersection of McGalliard Road and Country Club Road located in Liberty Township, Delaware County, Indiana for all traffic.
- 2. Title 5, Chapter 4, Section 8, is to be amended as follows:
 - A. There shall be a speed limit of 30 miles per hour on McGalliard Avenue from SR 67/3 and US 35 ("the By-Pass) east to CR 333E in Center Township until County Club Road and then in Liberty Township, Delaware County,
 - B. There shall be a speed limit of 40 miles per hour on Centennial Avenue from the Randolph/Delaware County line west to County Road 650E in Liberty Township, Delaware County, Indiana.

 There shall be a speed limit of 40 miles per hour on the speed limit on CR
 - 800E starting at SR 32 and headed north to Edgewater Road in Delaware Township, Delaware County, Indiana.

- 3. The County Highway Department of Delaware County, Indiana, is hereby authorized to erect appropriate signage pursuant to the Indiana Manual on Uniform Traffic Control Devices.
- The penalty for violation of this ordinance shall be as herein setforth in Article XVI, Section 16-1.
- 5. This ordinance shall be in full force and effect from and after its passage and publication.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA THAT:

SECTION 1. The Board of Commissioners hereby identifies the properties listed on EXHIBIT A, attached hereto, as that for which the Board of Commissioners desires to transfer to a nonprofit entity to be used for the public good.

SECTION 2. The Board of Commissioners will conduct a public hearing to consider the transfer of the properties to a nonprofit entity and said public hearing shall be set to occur on the 7th day of November, 2022, at 9:00 a.m. in the Delaware County Commissioner's Courtroom, 100 West Main Street, Room 309A, Muncie, Indiana 47305.

SECTION 3. The Board of Commissioners shall cause to be published a notice regarding the public hearing pursuant to of Ind. Code §5-3-1-2(b) and, prior to said public hearing, will accept written applications that are in compliance with the requirements from non-profit entities that are not otherwise ineligible pursuant to Ind. A RESOLUTION OF THE DELAWARE COUNTY, INDIANA BOARD OF COMMISSIONERS MAKING A FINAL DETERMINATION TO DEEDS TO A NONPROFIT ENTITY PURSUANT TO IND. CODE § 36-1.11-5.6

WHEREAS, Ind. Code § 36-1-11-5.6 sets out the procedures the Board of Commissioners may utilize to assign real property to a nonprofit entity that is created for agricultural, educational or recreational purposes; and

WHEREAS, the Board of Commissioners previously adopted Resolution No. 2022-020A, which identified certain parcels for which the Board of Commissioners now desires to assign to a nonprofit entity for use for the public good; and

WIIEREAS, the Board of Commissioners desires to transfer to a nonprofit entity for use for the public good is identified in Resolution 2022-020A for a nominal fee; and

WHEREAS, the Board of Commissioners accepted written applications from eligible nonprofit entities and, on November 7, 2022, conducted a public hearing to consider all applications and hear any opposition to a proposed assignment of the real estate parcels; and

WHEREAS, having considered the submitted applications and public comments presented at the public hearing, the Board of Commissioners now desires to make a final determination on the assignment of the identified real estate parcels.

IT IS THEREFORE RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA THAT:

SECTION 1. Having received and considered the applications from nonprofit entities, copies of which are attached hereto, the Board of Commissioners issues the final determination described in Exhibit A, attached hereto, regarding the proposed assignment to a nonprofit entity of the parcels identified in Resolution 2022-020A.

SECTION 2. The assignment of the identified parcels shall be completed according to the specific terms and conditions described in the Commissioners' final determination of the Agreement that the County enters into with the nonprofit for the parcels to be sold to them for a nominal fee.

<u>SECTION 3</u>. The Board of Commissioners hereby assigns the real estate identified in parcel numbers:

DEPARTMENT HEADS AND ELECTED OFFICIALS

- *Mr. John Coutinho, EMA Director, said November 9, 2022 at 10:00 a.m. there will be a dedication at the new flagpole, located at the Dispatch Center, in honor of Mr. Adam Grimes.
- **Mr. Flook said a few weeks ago when there was a water blow out from the pipe in the boiler room the Uninterrupted Power Supply (back-up of power) was ruined. A new UPS will be delivered on November 9, 2022.

Ms. Jeni Honeycutt, Executive Assistant, said Mr. Steve Foster, Superintendent, will provide invoices to turn this claim into insurance.

- ***Mr. Foster said he needs to know where and how to process the shingles from the Justice Center roof. An insurance claim was submitted in 2018, however it was not fixed. Mr. Foster has two bids that he will send to the Commissioners. Mr. Foster is also going to build a blast wall so the water cannot go directly onto the Uninterrupted Power Supply.
- ****Mr. Brad Bookout, Director of Economic Development, said he, Commissioner Henry, Mr. Bill Walters had a very successful trip to Italy. They met with 40 companies. Mr. Bookout provided details of the companies within the last five years that have come to Delaware County. Mr. Bookout provided details regarding construction and current happenings within Delaware County at this time.
- *****Mr. Tony Skinner, Delaware County Sheriff, said in January 2023 the provider of the jail/inmate communications will change to Combined Public Communications. Tyler will set the software up through the vendor at no cost to Delaware County.

The Commissioners would like Mr. Skinner to send the agreement to them via email.

******Commissioner King said the Commissioners along with the Judges recently learned that the operations of the detention facility will be reduced. This will be effective January 1, 2023. The detention center will no longer allow female detainees and the beds will be reduce from 22 to 10. Delaware County pays YOC \$550,000 yearly to operate. The Commissioners realize this will be dumped on Delaware County Commissioners. Judge Kimberly Dowling, Juvenile Court, was surprised to learn of the reduction also. If detainees are housed outside of the county it could be \$150 to \$175, per day, plus the transport of juveniles. Mr. Brooke has been in contact with their attorney.
