LETTER OF UNDERSTANDING

Ms. Angie Moyer, Project Manager, said INDOT contacted her regarding an project on 332. INDOT will close SR 332, 2.099 miles east of I-69 from July 5 until August 14, 2023. The letter below states June 30, however, INDO told Ms. Moyer the road would be closed on July 5, 2023. The proposed detour is N CR 700 W, W Jackson Street, CR 820 W. Ms. Moyer said INDOT is asking for approval.

President Henry said this was a surprise and INDOT "forgot" to notify the Commissioners. Henry asked that Mr. Kyle Johnson, fly the drone and get photographs of the area. A traffic study will need to be done and then another one after the closure. "No truck signs" should be installed to keep semis off of the roads.

Commissioner King said having Mr. Johnson to get photos will help, should there be damage to the roads.

Commissioner Riggin asked if INDOT was working on getting semis off at the exit of Daleville.

Ms. Moyer said detour signs are often ignored to find the quickest way to get to where they (semis) are going. Ms. Moyer will send the signage plan to the Commissioners. INDOT will only detour on state roads.

Commissioner King said the last time INDOT did a detour, it ended up costing Delaware County.

Dear Delaware County Board of Commissioners

This is a follow up letter to our recent discussion concerning the closure of the location listed above. Traffic restrictions are expected to begin <u>June 30, 2023</u> with an estimated completion date of <u>August 14, 2023</u>. The total closure time for this project will be approximately <u>45</u> days.

The Official Detour, in accordance with IC 8-23-21 and shown on the attached map, will utilize I-69 and US 35
The Unofficial Detour, as shown on the attached map, is proposed to be NCR 700 W. W Jackson St., CR 820 W
The Unofficial Detour will be in effect during the same time period as the Official Detour.

INDOT will set up and maintain the necessary signage and traffic control for the Official Detour route or arrange with others to furnish the necessary items. The Unofficial Detour route will not be signed as a detour. Your County Commissioners will be responsible for any necessary weight restriction signage on the Unofficial Detour.

INDOT agrees to reimburse your County for costs related to damage repair on the listed Unofficial Detour. Reimbursable work must be pre-approved by INDOT prior to the completion of any work. All expenses must be documented to be considered for reimbursement. Once the District has agreed to the documented expenses, INDOT and the County must execute an agreement concerning reimbursement for the repairs. This will not occur until after the INDOT Official Detour is eliminated.


LILLIE PLAT

DELAWARE COUNTY COMMISSIONERS AGREEMENT FOR CONTRACTUAL SERVICES

THIS AGREEMENT is made and entered into this day by and between the Delaware-Muncie Metropolitan Plan Commission, hereinafter referred to as "DMMPC", and the individual Hugh Smith, 557 E. Greenville Ave., Winchester, Indiana, 47394, hereinafter referred to as "Consultant", regarding Transportation Planning services with the Delaware-Muncie Metropolitan Planning Organization, hereinafter referred to as the "MPO".

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereto agree as follows:

- Services. The Consultant will provide Transportation Planning services dealing with the MPO including:
 - a. Guidance on coordination and correspondence with other agencies such as the Indiana Department of Transportation (INDOT), Federal Highway (FHWA), Federal Transit (FTA), and any other agencies as needed.
 - b. Creating and updating documents including the Delaware-Muncie Transportation Improvement Program (DMTIP), Delaware-Muncie Long Range Transportation Plan (MTP), Annual List of Obligated Projects (ALOP), ADA Title VI Plan, and any other mandated documents as needed; and assistance with completing amendments and modifications to any of the current documents as needed.
 - c. Assistance with air quality Conformity guidelines and procedures as needed.
 - d. Assistance with any other Transportation Planning procedures and other State and Federal guidelines related to Transportation Planning.

Consultant is an independent contractor and this Agreement shall not be deemed to create a relationship of employment, partnership, agency, or joint venture.

- Work Product. All work products created by Consultant pursuant to this Agreement shall be the property of Delaware County, Indiana.
- Term of Agreement. This Agreement shall commence on June 1, 2023 and shall terminate on December 31, 2023 unless extended by agreement of both parties.
- 4. Administration of Agreement. This agreement shall be administered by and through the DMMPC.
- 5. Compensation for Services. Compensation shall be paid on an hourly basis at a rate of thirty dollars (\$30.00) per hour. Time sheet records shall be maintained by the Consultant and submitted weekly
