Printing and Postage for Property Taxes- Brad Polk

Treasurer Brad Polk stated Master's Touch LLC is the company they use for printing costs and postage for property taxes. Last year the cost was \$34,500 and this year the cost is \$34,530.03. He stated they plan to use \$5,000-\$7,000 out of their own budget. Master's Touch LLC now provides E notices for tax payers. They would receive those by email and then could pay however they want to.

Building Upgrade Quotes – Tommie Humbert

Mr. Tommie Humbert asked for permission to build a salt barn and an add on to the west barn. Commissioner Brand asked Tommie to provide the quotes for the two projects.

Mr. Humbert stated for the source for the west the west barn add-on which is a 22x110x13 Newsome Construction was \$35,500, Thornburg and Sons was \$44,500, and Aker Construction was \$44,635. The salt barn is going to be 20x72x13. Newsome Construction was \$58,200, Thornburg and Sons was \$68,700, and Aker Construction was \$77,300.

MOTION: Commissioner Brand made a motion to approve Newsome Construction for the equipment barn and Newsome Construction for the salt barn as well. Those funds would come out of the revenue replacement fund.

Ms. Chery Dawson at 4214 W SR 28, expressed her concerns on solar panels near her home. Steven Hinds at 2706 S Tacoma Ave, addressed tax revenues from solar panels and property value guarantees
