Solar Moratorium - Stephen Brand

MOTION: Commissioner Brand made a motion to take the Solar Moratorium off the table.

Commissioner Brand provided an update on solar energy, noting discussions with various stakeholders, attendance at a National Grid Renewables meeting, and the recent sale of National Grid Renewables to Brookfield Asset Management. He also emphasized the importance of Economic Development Agreements with solar companies prior to permitting and mentioned ongoing discussions with Council leadership regarding this. He also touched on Small Modular Reactors and clarified their technology compared to traditional nuclear plants. He referred to Article 31 of the special use's standard regarding potential impacts of special uses.

Mr. Bill Walters presented the new agreement for international development, highlighting services provided and ongoing and potential projects. He noted that this was a reduction from the previous proposal. Discussion ensued regarding funding, with a suggestion to review with the Delaware County Redevelopment Commission.

Commissioner Brand noted several corrections: the spelling of Christy Nap's name, clarification regarding the Crown Castle letter, noting Commissioner Henry's motion to table the DCPD contract, correcting the spelling of "Invenergy" in his comments, and adding the approval of the New Norm agreement for Jamie Bane.

PRESENTATIONS:

SS4A Grant - ECIRPD AND DMMPC

Mr. Matthew Nichols from the East Central Indiana Regional Planning District (ECIRPD) and Kylene Swackhamer from the Delaware County Metropolitan Plan Commission (DMMPC) presented on the Safe Streets for All (SS4A) Federal Grant. They explained the grant's purpose to improve roadway safety and sought engagement and feedback from the Commissioners to serve on a steering committee. They clarified that they were not asking for funding, as ECIRPD was using its administrative funds for the grant. Commissioner Riggin volunteered to serve on the steering committee. Commissioner Brand supported this and asked that autonomous driving vehicle technology be considered in the study.

Muncie-Delaware Economic Development Alliance – Elizabeth Rowray

Ms. Elizabeth Rowray from the Muncie-Delaware Economic Development Alliance (EDA) presented a proposal for economic development services. She provided background on the EDA, its qualifications as the Local Economic Development Organization (LEO), staff experience, fiscal responsibility, and regional, statewide, and national partnerships. Chris Brazler, a site selection consultant, spoke in support of the EDA's work. Commissioner Brand stated that the proposal would be taken under advisement, and funding would need to be researched.

MOTION: Commissioner Brand made a motion to table the Muncie-Delaware Economic Development Alliance proposal for \$150,000 annually.

2025 Aerial Imagery Funding – Kyle Johnson

Mr. Kyle Johnson GIS, requested \$4,000 to help cover the 20% local share of the 2025 aerial imagery project. The total project cost was \$93,000, with 80% funded through reimbursement.

IPW On Call Contract (\$1,100 monthly fee) - Stephen Brand

Commissioner Brand presented an on-call service contract with Indiana Public Works (IPW) for work on the wet well at the Justice Center, with an estimated monthly fee of \$1,100. This was in response to issues with pumps and the "Muffin Monster".

Koorsen Contract- Stephen Brand

Commissioner Brand provided an update on the Koorsen Fire and Security auto-renewal contract. He had requested and reviewed service reports and was awaiting an updated 2025 service agreement after scheduling a meeting with Koorsen

IU Health Master Agreement – Pam McCammon

HR Director Pam McCammon presented the annual IU Health Master Agreement for the employee clinic. She noted a 4% price increase and discussed previous meetings regarding employee complaints. Commissioner Riggin expressed concerns about the increase and the need for deliverables from IU Health regarding clinic usage.

Crown Castle Agreement - Stephen Brand

Commissioner Brand discussed the cell tower agreement. Last month we did an agreement with Crown Castle and Mr. Brooke watched the meeting and came back with some comments specifically about the length of the term asking about whether we approved 30 years or 20 years and asking the Commissioners if we would agree to continue to negotiate for 20 years. Commissioner Brand stated that we need to make a motion to clarify and have a clean record that we're specifically approving AT&T as the sub on the cell tower at the highway department and we would need a second for that. The technical name of the lease will be CCA LLC which is who we're adding to the cell tower MOTION: Commissioner Brand made a motion to approve AT&T subtenant on the cell tower the highway department doing business as CCATT LLC and we give permission for Mr. Brooke to continue to negotiate towards a 20-year contract.

Ms. Linda Hansen from the League of Women Voters thanked Commissioner Brand for the solar ordinance update and confirmed the target date for a special meeting with the Metroplan Planning Commission in April and the timeline for public release of the ordinance. She also inquired about who was working on the ordinance. Commissioner Brand noted the timeline might be tight and could potentially be pushed back.

Ms. Cheryl Dawson, a resident on State Road 28, expressed concerns about the solar project along SR 28, including the possibility of seeing a map with setbacks, the large out-of-state landowner

involved, and the potential for eminent domain, referencing a bill in Kansas. Commissioner Brand indicated he believed the map was displayed at a public meeting at Cornerstone Center for the Arts and would try to obtain a copy.

Mr. Tim Nicam was signed up for public comment but was not present

Commissioner Henry also announced the departure of Angie Moyer after 29 years of service and acknowledged her significant contributions to the county. A small gathering was planned for her on Monday from 1 to 3 at the highway department.

Stephen Brand - Take Home Vehicle Eligibility

Commissioner Brand proposed adding language to the take-home vehicle eligibility policy, requiring residency in Delaware County, regular travel after hours (at least twice a week for county business), and being called out for job duties at least eight times a month, with documentation. He clarified this would exclude emergency vehicles (Sheriff, 911, EMS, and EMA). Commissioner Riggin supported the exclusion of emergency vehicles.

MOTION: Commissioner Brand made a motion to adopt this language into the handbook for review at the handbook meeting.

Commissioner Brand also provided several updates: the State of the City address, progress with artificial intelligence initiatives, a new building superintendent (Don Chambers) starting soon, a review of county electric bills and tariff rates, paving at the Justice Center planned for late April, filling potholes at the Justice Center, a meeting planned with E&B Paving to review the paving scope of work, the dependent benefits audit, an amended budget from the DLGF, the start of a continuous improvement initiative, an audio update for the meeting room, the establishment of a strategic finance committee and a strategic IT committee, the status of performance evaluations, and the signage and GPS on county vehicle.
