- 1. The Delaware County Auditor shall maintain a list of budget line items, which may be amended by the Council from time to time. The initial list of budget line items is attached hereto as 'Exhibit A' and incorporated by reference.
- 2. All departments shall include the budget line items as shown in Exhibit A, as amended from time to time, in their respective budget proposals for the 2026 budget year and all subsequent budget years.

This resolution shall become effective upon the date of passage. A copy shall be distributed to all departments of the government of Delaware County, Indiana.
