BZA 32-25 Muncie Aviation Company

Request for a variance from the Delaware County Subdivision Ordinance, Article IX, Section 13, to allow the division of a lot without meeting all of the Ordinances standards for separation of a restaurant through platting, also Article XVII, Section 3.B., to allow access to the restaurant through an ingress/egress agreement with the airport, and from the terms of the Delaware County Comprehensive Zoning Ordinance, Article XXX, Section 2E, for parking to be partially off site, and a variance from Article XXX, Section 5B, for a 0' rear and side setback rather than 15' setback for a variance of 15' and to intrude onto airport property through an encroachment agreement.

The restaurant is being separated from the airport property so that a new restaurant can move into the space. The only way to currently access this parcel is across other airport property. There is limited parking for the restaurant currently located on this parcel. We are requesting a variance for this property to not have any true road frontage and to be accessed by an easement, as well as to not have adequate onsite parking. This parcel as it currently exists is functioning in this way, having no true road frontage and limited onsite parking. There will be an ingress egress and cross parking easement & agreement recorded for this. We will also request a variance for a reduced rear setback.




