RESOLUTION 25-30

- **WHEREAS,** the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and
- **WHEREAS,** the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and
- WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to INDOT Project DES # 2200791, I-69 NB Bridge over N&S RR (CR 251) 0.66 mi N of SR332 (Bridge Deck Replacement), to decrease FY27 CN to the adjusted amounts of \$1,615,000 federal NHS funds and CN \$180,000 State matching funds, and a new estimated project total cost of \$8,122,000 was requested by INDOT; and
- **WHEREAS,** INDOT Project Des # 2200791 was previously submitted to the Interagency Conformity Group (ICG) for confirmation of exempt status with an exempt status concurrence date of March 25, 2025; and
- **WHEREAS,** the proposed amendment above was presented and approved by the Transportation Policy Committee (TPC) by e-vote concluding on September 2, 2025.

NOW, THEREFORE, BE IT RESOLVED by the Transportation Policy Committee of the DMMPC as follows:

Section 1. That the FY 2026-2030 DMTIP be amended for INDOT Project DES # 2200791, I-69 NB Bridge over N&S RR (CR 251) 0.66 mi N of SR332 (Bridge Deck Replacement), to decrease FY27 CN to the adjusted amounts of \$1,615,000 federal NHS funds and CN \$180,000 State matching funds as shown in Exhibit A.
