RESOLUTION 25-35

- **WHEREAS,** the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and
- **WHEREAS,** the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and
- WHEREAS, the proposed amended to the FY 2026-2030 DMTIP to add INDOT Project DES #2500747, I-69, 01.16 miles N of Madison/Delaware County line (Pipe Lining), FY 2027 PE in the amounts of \$90,000 federal NHS funds and PE \$10,000 State funds, and FY 2030 CN in the amounts of \$359,000 federal NHS funds and CN \$40,000 State funds; and
- **WHEREAS,** INDOT Project Des #2500747 to the FY 2026-2030 DMTIP was submitted to the Interagency Conformity Group (ICG) for confirmation of exempt status with an exempt status concurrence date of August 28, 2025; and
- **WHEREAS,** the proposed amendment above was reviewed and approved by the Transportation Policy Committee by e-vote concluding on September 12, 2025.

NOW, THEREFORE, BE IT RESOLVED by the Transportation Policy Committee of the DMMPC as follows:

Section 1. That the FY 2026-2030 DMTIP be amended to add INDOT Project DES # 2500747, I-69, 01.16 miles N of Madison/Del co line (Pipe Lining), FY 2027 PE in the amounts of \$90,000 federal NHS funds and PE \$10,000 State funds, and FY 2030 CN in the amounts of \$359,000 federal NHS funds and CN \$40,000 State funds as shown on the attached Exhibit A.
