



Annual List of Obligated Projects (ALOP) SFY 2025

The Delaware-Muncie Metropolitan Plan Commission (DMMPC) is responsible for the transportation planning in Delaware County, Indiana. DMMPC prepares an Annual Listing of Obligated Projects (ALOP) for which federal funds have been obligated the preceding State Fiscal Year. This ALOP satisfies requirements from the Indiana Department of Transportation (INDOT), Federal Highway Administration (FHWA), and Federal Transit Administration (FTA).

An obligated project is a transportation project which has received authorization to proceed by the appropriate federal agency. The authorization represents a commitment to pay the federal share of the cost of a project. The FAST Act requires that the ALOP is prepared and made public in order to make the public aware of how federal transportation funds are spent.

DMMPC's ALOP for State Fiscal Year 2025 also includes Indiana Department of Transportation (INDOT) projects in the Muncie Metropolitan Planning Area (MPA). Projects for which funds are obligated may not be initiated or completed in the program year, and the amount of the obligation may not equal the total cost of the project. This list of obligated projects was produced by DMMPC in cooperation with INDOT.
