RESOLUTION 25-60

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

WHEREAS, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

WHEREAS, the proposed modification to the FY 2026-2030 DMTIP to decrease INDOT project DES #2001991, NB over Cardinal Greenway, 2.25 mi. S of SR 32, to decrease FY 2028 CN from \$4,092,800 NHPP to \$4,019,000 Federal NHS funds and to decrease CN State funds from \$1,023,000 to \$1,005,000 for a total decrease of \$92,000 and move to FY27 was requested by INDOT; and

WHEREAS, INDOT Project Des #2001991 was submitted to the Interagency Conformity Group (ICG) for confirmation of exempt status with an exempt status concurrence date of March 27, 2025.

WHEREAS, the proposed modification above was approved and processed by the Muncie-Delaware Metropolitan Plan Commission (DMMPC) Muncie MPO on December 17, 2025.

NOW, THEREFORE, BE IT RESOLVED by the Delaware Muncie Plan Commission (DMMPC) as follows:

Section 1. That the FY 2026-2030 DMTIP be modified for INDOT project DES #2001991, NB over Cardinal Greenway, 2.25 mi. S of SR 32, to decrease FY28 CN from \$4,092,800 to \$4,019,000 Federal NHS funds and to decrease CN State funds from \$1,023,200 to \$1,005,000 for a total decrease of \$92,000 and move to FY27 as shown on the attached Exhibit A.
