## RESOLUTION 25-57

**WHEREAS**, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

**WHEREAS**, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

**WHEREAS**, the proposed amendment to the FY 2026-2030 DMTIP to add INDOT project DES #2401694, 0.11 mi S of SR 332 to 0.08 mi S of US 35/SR 28, to add FY26 PE in the amounts of \$3,960,000 Federal NHPP funds and to add PE State funds in the amounts of \$440,000 for a total amount of \$4,400,000 was requested by INDOT; and

**WHEREAS**, the proposed amendment to the FY 2026-2030 DMTIP to add INDOT project DES #2401694, 0.11 mi S of SR 332 to 0.08 mi S of US 35/SR 28, to add FY 2029 CN in the amounts of \$26,204,000 Federal NHPP funds and to add CN State funds in the amounts of \$2,912,000 for a total amount of \$29,116,000 was requested by INDOT; and

**WHEREAS**, the proposed amendment above was reviewed and approved by the Transportation Policy Committee via email on December 23, 2025 and is contingent on Interagency Conformity Group (ICG) confirmation of exempt status.

**NOW, THEREFORE, BE IT RESOLVED** by the Delaware Muncie Plan Commission (DMMPC) as follows:

**Section 1.** That the FY 2026-2030 DMTIP be amended to add INDOT #2401694, 0.11 mi S of SR 332 to 0.08 mi S of US 35/SR 28, to add FY26 PE in the amounts of \$3,960,000 Federal NHPP funds and PE \$440,000 State funds for a total amount of \$4,400,000 as shown on the attached Exhibit A.

**Section 2.** That the FY 2026-2030 DMTIP be amended to add INDOT DES #2401694, 0.11 mi S of SR 332 to 0.08 mi S of US 35/SR 28, to add FY29 CN in the amounts of \$26,204,000 Federal NHPP funds and CN \$2,912,000 State funds for a total amount of \$29,116,000 as shown on the attached Exhibit A.
