RESOLUTION 25-55

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

WHEREAS, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to add RW to INDOT project DES #2300691, US 35 from CR 875 W to 520 ft East of CR 875 W (MM 245), to add FY 2027 RW in the amounts of \$18,000 Federal NHPP funds and to add RW State funds in the amounts of \$2,000 for a total amount of \$20,000 was requested by INDOT; and

WHEREAS, the proposed amendment above was reviewed and approved by the Transportation Policy Committee via email on December 23, 2025 and is contingent on Interagency Conformity Group (ICG) confirmation of exempt status.

NOW, THEREFORE, BE IT RESOLVED by the Delaware Muncie Plan Commission (DMMPC) as follows:

Section 1. That the FY 2026-2030 DMTIP be amended to INDOT DES #23000691, US 35 from CR 875 W to 520 ft East of CR 875 W (MM 245), to add FY27 RW in the amounts of \$18,000 Federal NHPP funds and RW \$2,000 State funds for a total amount of \$20,000 as shown on the attached Exhibit A.
