RESOLUTION 25-54

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

WHEREAS, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP for Delaware County project DES #2100088, BR #193, Memorial Drive over White River 920 feet west of the Muncie Bypass (replace superstructure and deck), to increase FY 2026 CN funds to \$33,600 Federal STBG funds and \$8,400 local matching funds, for a total increase of \$30,000 was requested by Delaware County; and

WHEREAS, Delaware County project DES #2100088 was submitted to the Interagency Conformity Group (ICG) for confirmation of exempt status, with an exempt status concurrence date of December 18, 2025; and

WHEREAS, the above amendment was reviewed and approved by the TPC with an e-vote concluding on December 18, 2025.

NOW, THEREFORE, BE IT RESOLVED by the Transportation Policy Committee of the DMMPC as follows:

Section 1. That the FY 2026-2030 DMTIP be amended for Delaware County project DES #2100088 to increase FY26 CN funds to \$33,600 Federal STBG funds and \$8,400 local matching funds, for a total increase of \$30,000 as shown on the attached Exhibit A.
