RESOLUTION 25-47

- WHEREAS**, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and
- WHEREAS**, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and
- WHEREAS**, the proposed amendment to the FY 2026-2030 DMTIP to City of Muncie project DES #2003048, McGalliard Road from Granville Avenue to Muncie Bypass, HMA Overlay, to add FY26 PE in the amounts of \$214,700 STP 3 funds and \$53,700 local match funds and to move CN funds from FY28 to FY27 was requested by the City of Muncie; and
- WHEREAS**, project DES #2003048 was previously submitted to the Interagency Conformity Group (ICG) for confirmation of exempt status with an exempt status concurrence date of July 22, 2022; and
- WHEREAS**, the proposed amendment was reviewed and approved by the Transportation Policy Committee by e-vote concluding on November 11, 2025.

NOW, THEREFORE, BE IT RESOLVED by the DMMPC as follows:

Section 1. That the FY 2026-2030 DMTIP be amended for City of Muncie project DES #2003048, McGalliard Road from Granville Avenue to Muncie Bypass, HMA Overlay, to add FY26 PE in the amounts of \$214,700 STP 3 funds and \$53,700 local match funds and to move CN funds from FY28 to FY27 as shown in Exhibit A.
