RESOLUTION 25-46

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

WHEREAS, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

WHEREAS, the proposed amendment to add Delaware County project DES #2100088, Bridge #193, Memorial Drive over White River 920 feet west on Muncie Bypass, replace superstructure and deck, to add \$9,600 FY26 CN Federal STBG funds and \$2,400 FY26 CN local match funds, for a total of \$12,000 FY26 CN funds was requested by Delaware County; and

WHEREAS, project DES #2100088 was previously submitted to the Interagency Conformity Group (ICG) for confirmation of exempt status with an exempt status concurrence date of April 21, 2021; and

WHEREAS, the proposed amendment above was reviewed and approved by the Transportation Policy Committee (TPC) on October 15, 2025.

NOW, THEREFORE, BE IT RESOLVED by the Transportation Policy Committee of the DMMPC as follows:

Section 1. That the FY 2026-2030 DMTIP be amended to add Delaware County project DES #2100088, Bridge #193, Memorial Drive over White River 920 feet west on Muncie Bypass, replace superstructure and deck, to add \$9,600 FY26 CN Federal STBG funds and \$2,400 FY26 CN local match funds, for a total of \$12,000 FY26 CN funds as shown on the attached Exhibit A.
