RESOLUTION 25-42

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

WHEREAS, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to add INDOT Project DES #2500051, AASHTOware Safety Software, FY 2026 PE in the amounts of \$696,000 federal HSIP funds and PE \$174,000 State funds was requested by INDOT; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to add INDOT Project DES #2500051, AASHTOware Safety Software, FY 2027 PE in the amounts of \$360,00 federal HSIP funds and PE \$90,000 State funds was requested by INDOT; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to add INDOT Project DES #2500051, AASHTOware Safety Software, FY 2028 PE in the amounts of \$360,00 federal HSIP funds and PE \$90,000 State funds was requested by INDOT; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to add INDOT Project DES #2500051, AASHTOware Safety Software, FY 2029 PE in the amounts of \$360,00 federal HSIP funds and PE \$90,000 State funds was requested by INDOT; and

WHEREAS, INDOT Project Des# 2500051 to the FY 2026-2030 DMTIP was submitted to the Interagency Conformity Group (ICG) for confirmation of exempt status with an exempt status concurrence date of October 20, 2025.

WHEREAS, the proposed amendment above was reviewed and approved by the Transportation Policy Committee via email concluding on December 8, 2025.

NOW, THEREFORE, BE IT RESOLVED by the Transportation Policy Committee of the DMMPC as follows:

Section 1. That the FY 2026-2030 DMTIP be amended to add INDOT Project Des#2500051 AASHTOware Safety Software, PE FY 2026 \$696,000 federal HSIP funds and PE \$174,000 State funds as shown on the attached Exhibit A.


Section 2. That the FY 2026-2030 DMTIP be amended to add INDOT Project Des#2500051 AASHTOware Safety Software, PE FY 2027 \$360,00 federal HSIP funds and PE \$90,000 State funds as shown on the attached Exhibit A.

Section 3. That the FY 2026-2030 DMTIP be amended to add INDOT Project Des#2500051 AASHTOware Safety Software, PE FY 2028 \$360,00 federal HSIP funds and PE \$90,000 State funds as shown on the attached Exhibit A.

Section 4. That the FY 2026-2030 DMTIP be amended to add INDOT Project Des#2500051 AASHTOware Safety Software, PE FY 2029 \$360,00 federal HSIP funds and PE \$90,000 State funds as shown on the attached Exhibit A.


