RESOLUTION 25-44

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

WHEREAS, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

WHEREAS, the proposed modification to the FY 2026-2030 DMTIP for INDOT Project DES #2201265, SR 67 at SR 3 to US35 at SR32 (3.53 mi), FY 2027 CN from \$1,406,562 to \$2,031,000 federal HSIP funds and to decrease CN state funds from \$351,641 to \$226,000 for a decrease; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP for INDOT Project DES #2201265, to add FY 2026 PE in the amounts of \$76,500 federal HSIP funds and PE \$8,500 State matching funds for a total PE amount of \$85,000; and

WHEREAS, the proposed amendment above was reviewed and approved by the Transportation Policy Committee via email on December 23, 2026 and is contingent on Interagency Conformity Group (ICG) confirmation of exempt status.

NOW, THEREFORE, BE IT RESOLVED by the Transportation Policy Committee of the DMMPC as follows:

Section 1. That the FY 2026-2030 DMTIP be modified for INDOT Project Des#2201265, FY 2027 CN from \$1,406,562 to \$2,031,000 federal HSIP funds and to decrease CN state funds from \$351,641 to \$226,000 as shown on the attached Exhibit A.

Section 2. That the FY 2026-2030 DMTIP be amended for INDOT Project Des#2201265, FY 2026 PE in the amounts of \$76,500 federal HSIP funds and PE \$8,500 State matching funds to add a total PE amount of \$85,000 as shown on the attached Exhibit A.
