BZA 02-26 Jurisdiction: Board of Zoning Appeals

Being a public hearing on the matter of an application filed by **Kingdom Recovery, LLC.**, requesting a variance of use from the terms of the City of Muncie Comprehensive Zoning Ordinance, to allow group housing in an existing church building for long-term sober living in a single-family residence zone, and to allow off site parking, and to allow the parking lot to not be paved rather than developed according to engineer standards, on premises located at 304 North Waldemere Avenue, Muncie, Indiana, as more accurately described in the application.

BZA 04-26 Jurisdiction: Board of Zoning Appeals
Being a public hearing on the matter of an application filed by **McDonalds and Pegasus Future II, LLC.**, requesting a variance from the terms of the City of Muncie Comprehensive Zoning Ordinance to allow a 45' tall pole sign for a new restaurant on a corridor road, on premises located on the southeast corner of Macedonia Avenue and 29th Street, Muncie, Indiana, as more accurately described in the application.

BZA 05-26 Jurisdiction: Board of Zoning Appeals
Being a public hearing on the matter of an application filed by **Game of Homes, LLC.**, requesting a variance of use from the terms of the City of Muncie Comprehensive Zoning Ordinance, to allow two dwellings in a single-family residence zone, and a variance to allow a reduced rear setback of 11', rather than 15', for a variance of 4' for one of the dwellings, on premises located at 1006 West Wayne Street, Muncie, Indiana, as more accurately described in the application.

BZA 06-26 Jurisdiction: Board of Zoning Appeals
Being a public hearing on the matter of an application filed by **Raychelle Johnson**, requesting a variance of use from the terms of the Delaware County Comprehensive Zoning Ordinance, to allow a commissary for a food truck, to allow a commercial store with a commercial kitchen in a pole barn, and to allow a 4'x8' sign to advertise the business., on premises located at 11700 North Old Granville Road, Albany, Indiana, as more accurately described in the application.
