

**ORDINANCE NO. 2010-007A**  
**AMENDMENT TO ORDINANCE NO. 2006-01**  
**EMS MEDICAL SUPPLY FUND**

ORIGINAL

WHEREAS, Delaware County Commissioners are responsible for establishing and setting fees charged by the Delaware County EMS (Emergency Medical Service)and;

WHEREAS, The County Commissioners reduced the amount funding the "EMS Pension Supplement Fund" from \$39.00 to \$25.00 by amendment to the Delaware County Code 1-7-31 in Ordinance 2006-01 and;

WHEREAS, Delaware County EMS also has funds established for \$40.00 to go into its Capital Improvement Fund, and \$11.00 to go into its EMS Ambulance Replacement Fund to assist in providing ambulances for the volunteer EMS service in Delaware County and;

WHEREAS, It is the intent to establish another fund where EMS medical supplies may be purchased from, thereby allowing Delaware County Council to eliminate the Medical Supply Budget, in the current EMS Budget and;

WHEREAS, this ordinance will require the approval of both the County Commissioners and the County Council to enact all of the changes necessary for the improvement of Emergency Medical Services and;

NOW THEREFORE BE IT RESOLVED BY THE COMMISSIONERS OF DELAWARE COUNTY that:

An amendment to reduce Delaware County EMS "Pension Supplement Fund" from \$25.00 to \$11.00 and to continue the fund and;

To establish a non- reverting fund from which to purchase Medical Supplies by way of the normal claims process established by the Delaware County Auditor's office and;

\$14.00 from each user fee, charged and collected, by the County EMS be placed in said "Medical Supply Fund" in accordance to the same manner as the Capital Improvement Fund, the EMS Pension Fund, and the Ambulance Replacement Fund for the EMS Volunteer agencies and;

All other charges for EMS fees will continue unchanged and enforced as follows;

DCEMS Capital improvement fun \$40.00  
DCEMS Ambulance replacement fund \$11.00  
DCEMS 457 Pension Fund \$11.00  
DCEMS Medical supplies fund \$14.00






