RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE COUNTY OF DELAWARE, INDIANA, AGREEING TO TRANSFER PARCELS TO ABUTTING LAND OWNERS

WHEREAS, Indiana Code 36-1-11-5.9 sets out the procedures for transfer of real property acquired by tax default to abutting landowners; and

NOW THEREFORE BE IT RESOLVED that the Board of Commissioners will provide written notice of its intent to sell such identified parcels to the owner of record of each such contiguous parcel, and will process said letters of intent and sell the identified parcels in accordance with Ind. Code 36-1-11-5.9.
