WHEREAS, the Delaware County Commissioners desire to have these properties used for the City of Muncie, Indiana

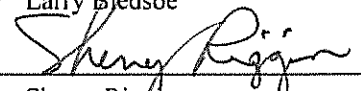

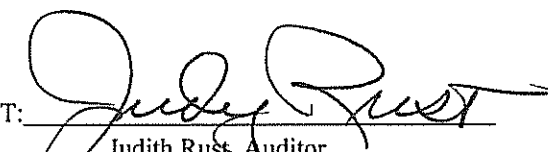
