RESOLUTION CONCERNING TAX SALE PROPERTIES AND THE HARDEST HIT FUND

WHEREAS, the Community Development Department of the City of Muncie has advised the County that there are some properties scheduled for the Fall, 2014 Tax Sale, which have previously gone unsold in tax sales, which properties are eligible for the City's Hardest Hit Fund proceeds, for the purpose of rehabilitating such properties as funds are available;

WHEREAS, the Commissioners hold the tax certificates for these properties, which are described on the attached list;

WHEREAS, the Commissioners may remove these properties from the tax sale, and assign such properties to the Muncie Redevelopment Corporation, subject to its acceptance of such properties;

WHEREAS, by so doing, such properties will be improved and blight reduced, and some of such properties may be returned to the tax rolls.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of Delaware County that the Commissioners will remove these properties from the Fall 2014 Tax Sale and shall assign such properties to the Muncie Redevelopment Corporation for application for Hardest Hit funds, subject to acceptance by the MRC of such properties. It not accepted, these properties shall be returned to the next available tax sale.
