The County desires RSS to lead the New World CAD conversion process from their existing version to the new Enterprise operating system at the PSAP. The County utilizes New World Suite for CAD, Mobile, RMS, and Corrections. RSS' responsibilities are limited to CAD and its integration with the remaining modules.

RSS recognizes that in 2021 the County delayed their "go-live" with New World due to limited resources for training. New World project managers and County representatives have maintained status conference calls while the County was responsible for continuing work on the project.

The County is unsure of the "status" of readiness for CAD transition to Enterprise and can only provide a limited estimate of its state of readiness.

RSS will provide one or more subject matter experts to facilitate the preparation of the upcoming transition of CAD to Enterprise. The subject matter experts will provide project support virtually and onsite as required and available. The County shall provide RSS with login credentials that allows subject matter experts access to the existing CAD version and to the Enterprise version. RSS will work with County representatives and first responder agencies to evaluate and then prepare for the transition to Enterprise.

RSS will participate on regularly scheduled conference calls with the vendor.

RSS will co-manage the project with the County's Project Manager (Jim Flook) and PSAP management. RSS will provide transitional training to existing or new CAD Administrator(s) as required.

A discussion of whether the performance standards are being met and recommendations for remedial actions will be included in the monitoring report.

The Election Board hereby engages McClellan, not as any employee or agent, but as an independent contractor to provide legal services to the Election Board and to attend Election Board meetings when scheduled and to advise, research and consult concerning issues surrounding the Indiana Election laws.

FOR AND IN CONSIDERATION of the above-mentioned services to be rendered to the Election Board, McClellan will be paid a flat rate of \$4,000.00 for the 2022 calendar year.

- All activities by McClellan shall comply with all applicable federal, state and local laws, ordinances, rules and regulations.
- 2. McClellan shall keep a file containing any and all correspondence, emails, and other research materials created on behalf of the Election Board, which will be available for the Election Board to review and/or secure copies of the same. The parties agree that all documents applicable to this Agreement shall be kept for a period of not less than three (3) years.
- 3. Should the Election Board find it necessary to initiate a legal proceeding or becomes a defendant in a legal proceeding in addition to the terms of this Agreement, McClellan shall be paid at an hourly rate not to exceed \$250 per hour for his services rendered in initiating or defending Election Board required litigation.
- Neither party to this Agreement shall use, disclose, copy, publish, advertise, or market any information obtained in connection with the work performed or services provided under the terms of this Agreement.

Muncie Land Bank has staff and they are reaching out to people who would take property and reuse it. Muncie Land Bank requests permission to take a certain amount of properties on an annual basis. The goal is to let the county know that we would like to establish a process of properties that have gone through the tax lien once and to turn these properties over to vetted and well examined people that will reuse the property. Ten property auctions have taken place, Muncie Land Bank have went through a process to make sure that the bidders are not scammers.

Commissioner Henry agrees and would like to get properties back on the tax roll. Henry said Muncie Land Bank could send a six-month progress report on the sales and upgrades. Commissioner Henry said this would be great.

ORDINANCE 2022-__002

DELAWARE COUNTY COMMISSIONERS ORDINANCE FOR DELAWARE COUNTY PRO-SE SELF HELP PROGRAM (DELAWARE COUNTY CIRCUIT COURT)

WHEREAS, the Delaware County Circuit Court has implemented a Self-Help Legal Center; and

WHEREAS, the Delaware County Circuit Court is being awarded funds via grant from the Indiana Supreme Court, Family Court grant program to further advance this program; and

WHEREAS, the uses of the funds are controlled by the grant agreement with the Indiana Supreme Court, Office of Judicial Administration, Indiana Office of Court Services; and

WHEREAS, the Board of Commissioners are supportive of the Delaware County Circuit Court receiving these funds and needs to set up a separate fund for the deposit and use of the funds by the Delaware County Circuit Court.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA:

- 1. A separate fund shall be established by the Delaware County Auditor for the purpose of receiving any and all funds for the Family Court Grant as awarded by the State of Indiana for the Delaware County Circuit Court Pro-Se Self Help Program.
- 2. The Delaware County Auditor shall issue a budget fund number of Size with respect to the funds received by the Delaware County Circuit Court and said funds shall be non-reverting.
- Said funds shall reimburse expenses spent and shall be used by the Delaware County Circuit Court, without appropriation, as per specified by the Family Court Grant.
