# JUDGE LINDA RALU WOLF SEEKING SUPPORT TO CHANGE THE CURRENT MASTER COMMISSIONER POSITION TO MAGISTRATE POSITION

#### JUDGE WOLF-MAGISTRATE POSITION

Judge Wolf presented information regarding changing the position of Master Commissioner to Magistrate. At the end of the hearings, the Master Commissioner's findings and recommendations are sent to the Judge for review. This causes a delay in getting the decision to the litigants. Litigants are waiting on the sitting Judge to review the recommendations, sometimes the Judge is in court so the review may not happen until the end of day or next day. There are several steps to the process. If the position was changed, the Magistrate could/would have the authority to make a decision and also handle criminal cases.

Benefits and retirement would be paid through the State because the Magistrate is a State employee. The total amount of county general would be \$42,000 compared to the current cost of \$77,730.65. General Assembly determine State salaries.

A "letter of support" was provided by Council on April 26, 2022. This would be sent to Summer Study Committee then legislators and a recommendation to General Assembly in a form of a bill and then in hopes that they would authorize the Magistrate position. This is a long process and a very important process which allows Judges to make sure that we have local support for the proposal.

It has been brought to our attention that there is a need for a full-time magistrate for Delaware Circuit Courts. We support the request for a full-time magistrate for Delaware County.

Having a magistrate will assist in curtailing additional expense to the county. Furthermore, the magistrate will be able to issue his own orders in a more expeditious manner for the benefit of litigants. The current court commissioner position would be replaced by the full-time magistrate position. No other staffing changes or expenses would be necessary to facilitate this change.

We understand that it would mean that the magistrate would be a state employee, predominantly paid by the state, and the county would be required to pay a portion of the magistrate salary. We are willing to pay the county portion of the magistrate's salary.


# ASHTON LAND SURVEYOR - COLLINSVILLE AND ERNSTBERGER SUBDIVISIONS



# INTERLOCAL AGREEMENT WITH DELAWARE COUNTY SHERIFF

Mr. Brooke presented the interlocal agreement between the Prosecutors office and Sheriff's office. A county officer will be assigned to the unit and be paid \$50,000 in salary and benefits for the deputy from the unit.

### DELAWARE COUNTY HIGH TECH CRIMES UNIT INTERLOCAL AGREEMENT WITH THE DELAWARE COUNTY SHERIFF

This Delaware County High Tech Crimes Unit (the "Unit") Interlocal Agreement (this "Agreement") is entered into by and between the Board of Commissioners of Delaware County, Indiana (the "County"), the Delaware County Sheriff (the "Sheriff"), and the Delaware County Prosecutor's Office (the "Prosecutor's Office").

WHEREAS, in 2021 House Enrolled Act 1082 added section 33-39-8-7 to the Indiana Code. This provision allows "[t]he Indiana Prosecuting Attorney's Council to . . . establish high tech crimes units to assist prosecuting attorneys in investigating, collecting evidence, and prosecuting high tech crimes." High tech crimes are defined as "a criminal act that is either: (1) committed with or (2) assisted by digital . . ., network, or communications technology." The IPAC "may select up to ten (10) counties that collectively represent the north, south, east, west, and central geographic areas of Indiana" ensuring state-wide coverage. Indiana's High Tech Crime Units or HTCU's will focus on digital forensics which, according to the National Institute of Standards and Technology, is "the field of forensic science that is concerned with retrieving, storing and analyzing electronic data that can be useful in criminal investigations" to include "information from computers, hard drives, mobile phones and other data storage devices;"

WHEREAS, on November 2, 2021, the IPAC informed the Delaware County Prosecutor that his office has been selected to receive approximately \$285,000 annually in state funding to establish a regional high tech crime unit; and

# DEPARTMENT HEADS AND ELECTED OFFICIALS DRUG TESTING

Ms. Pam McCammon, Human Resource Director, said drug testing currently is done by Concentra. The price of the test started out at \$15 and is now \$42. This is paid by the employee. The clinic is willing to do drug testing for \$18 to \$20 depending on the type of test. Workers comp will also be turned over to the clinic. This is all a savings to Delaware County. The clinic does not handle money, these tests are paid by the employee.

Commissioner Henry would like to start paying for the drug tests.

MOTION: Commissioner Henry made a motion to start paying for pre-employment drug test.

SECOND: Commissioner King

YEAS: Commissioner Henry, Commissioner King, President Riggin

Mr. Brooke will draft a resolution for the clinic pre-employment drug test and workers comp.

President Riggin said businesses have had to lower their standards of expectations for employees, however, President Riggin would like to have random drug testing.

Ms. McCammon said this can easily be done and she will look into this.

Ms. Marta Moody is speaking as a Board Member of Community Enhancement Project (CEP). CEP is willing to take over maintenance on the raised planters. Once CEP is finished with the job they then would submit an invoice for reimbursement.

President Riggin asked that they clean the moss on the statues too.

MOTION: Commissioner Henry made a motion to approve the concept of Ms. Moody's recommendations regarding maintenance of the raised planters.

SECOND: Commissioner King

Ms. Moody said this would be to reimburse for maintenance, landscaping and time.

CEP maintains areas for City of Muncie and Jay-Crew is used for these projects. They do have a quote from Jay Crew.

Commissioner Brooke said a formal agreement is needed.

President Riggin said the Historical Society had done repairs.

Ms. Moody said CEP is willing to also work on the stormwater rain garden project in front of the county building.

Commissioner Henry said he approved the stormwater rain garden as well.

Commissioner King asked about the Memorandum of Understanding (MOU) with Indiana Reentry and Correctional Support Program (IRACS).

Mr. Brooke said a special meeting could take place to keep things moving due to timeline but Mr. Brooke has not been given an outline as of date.

Mr. Tommy Humbert, Highway Superintendent, said the Country Village bid process has started. Ms. Angie Moyer and Mr. Troy Landers has helped with the project.

Mr. Humbert said the 90% for 90 days is a turn off to candidates that are getting interviewed for positions at the Highway.

Commissioner King said that is something Council would need to review and it would require an update on the ordinance.

Commissioner Henry agrees with Mr. Humbert.

Ms. Shelley Harvey, Office Manager and Mr. Kelly Bryan, Chief Public Defender, said they are backlogged with cases from COVID. They have lost four Public Defenders recently and cannot compete with other counties regarding the salary paid by Delaware County. An explanation was provided to Council regarding supplementing these cases when someone leaves and a new person comes in as a Public Defender. When a Public Defender quits someone has to then take their workload. They have openings but no applicants. The state also has American Rescue available. There are certain levels to cases in which an attorney can take, not all are available to take just any case. Ms. Harvey would like to get permission to use some supplemental funds. Some of these people have been in jail for two years and this is not acceptable. The short-term problem is COVID cases and the long-term problem is Delaware County cannot compete with other counties. Hamilton and Marion County have been reached out to for Public Defenders but for the pay they will only make the drive for so long. In a baseball analogy it would be to create a farm system. Delaware County could get through this and then qualification is a product of years of practice, jury trials that the attorney conducted or was second chair. Get people from Muncie who want to stay in the area, get them into our system and make the salary attractive. This all was presented to County Council on April 26, 2022.

President Riggin asked if the Public Defender Board could provide recommendation.

Mr. Brooke said this should be addressed to Council because Delaware County is the lowest pay in the area. There is money available for jury trials in the American Rescue Plan.

Ms. Emily Anderson, Court Administrator, said jury trial money was not spent during COVID and went back to general fund and was not spent.

Ms. Wolfe seconds what each speaker stated and by constitution it is required that a Public Defender be hired, if needed. Required by law, each mental patient is assigned a Public Defender.
