### **Construction Questions**



The RFP mentions renovation of existing improvements, can you provide as built plans of the area to be renovated? If a full set of plans is available, it would be helpful to understand how systems tie together and design assumptions for the larger facility.

RESPONSE: THE AREA TO BE RENOVATED IS PART OF AN OVERALL JUSTICE CENTER AND JAIL AREA. THE COUNTY CAN TRY AND LOCATE PLANS FOR THE RENOVATED AREA.

Please provide a current site plan that shows any improvements, to be used in locating exterior recreation space. How many patients would be allowed to use the recreational facilities at any given time?

THE COMPLEX IS LOCATED AT 3100 S. TILLOTSON AVE. AND IS AVAILABLE ON THE COUNTY'S WEBSITE. THE AREA IS AS FOLLOWS:



The RFP requires 15 male and 15 female beds. We understand these rooms are not private, can you provide the number of 6+ bedrooms, 5, 4, 3, 2 and single bedrooms? Will 15 male and 15 female beds be enough to sustain an operational program?

RESPONSE: WE HAVE CONSULTED WITH SOME CONSULTANTS AND BASED UPON THEIR ANALYSIS THE NUMBER OF BEDS IS THE QUANTITY IS WHAT THE COUNTY'S CONSULTANTS BELIEVE WILL BE APPROVED BY THE STATE OF INDIANA AT THIS TIME. However, it might be reasonable to provide rooms at 5, 4, 3, two in one single room. The reason behind this is a graduated system based on accomplishments

as those that continue in the program are rewarded with improved space in their bedroom. This would make 15 for males and 15 for female spots, for a total of five rooms for males and five rooms for females. The other option could be 3 rooms of four, one room of two and a single room. This counts 5 rooms. Size of the rooms should be consistent with the number of people in them. Bunk beds could be utilized.

- If 15 male and 15 female beds is all the program requires, will you consider a 1 story building that does not have the capability to be expanded?
- RESPONSE: YES This will be dependent on the needs and capabilities of the service provider as well as the approval of the State.
- Please confirm that the rooms do not require an in-suite patient toilet area and shower?
   How many dedicated medical isolation rooms are required? We understand no secure rooms/cells are required.

•RESPONSE: THE ROOMS SHOULD BE PRIVATE, BUT NOT REQUIRING AN INDIVIDUAL TOILET OR SHOWER AREA WHICH WILL BE COMMUNAL. A single bedroom could be

- considered to be a medical isolation area as well.
- Do medical isolation rooms have any special HVAC requirements?
- How will this facility be licensed, as correctional, inpatient psychiatric acute setting, inpatient
- rehabilitation therapy or other?
  - RESPONSE: NO SPECIAL HVAC REQUIREMENTS ARE UNDERSTOOD BY THE COUNTY, BUT THERE COULD BE DEPENDING ON THE FACILTY OPERATOR'S
- NEEDS. The question more relates to high flow ventilation filtration for airborne pathogens
- for isolation rooms. This for that a significant cost. If someone was in a single room requiring
- high flow ventilation filtration systems they may require a transfer to a facility outside this
- unit. It would be a consideration to place this high flow system with filtration is a separate cost but unlikely to be needed. This will not be an inpatient psychiatric or acute care setting under any circumstances.
- Is there an expectation to follow FGI Guidelines for the use answered above?
- How many group therapy rooms are required? Or follow FGI guidelines.
- RESPONSE: FOLLOW FGI GUIDELINES 2 group therapy rooms could be here and used for other purposes as well. At least one could be shared between males and females. If two were available that could be utilized for group therapy, visitation room, eating area or other possible
- available that could be utilized for group therapy, visitation room, eating area or other possible uses.
  - How many exam/consult rooms are required? Or follow FGI guidelines
- RESPONSE: FOLLOW FGI GUIDELINES One exam slash medical consultation room would be required, and include examination table with hey office slash consultation area. This would also be available for intake evaluations investments if no other space is available. Drug testing could be performed out of this area although is that necessary to have a full exam room for this obviously. It would be more accessible if a bathroom was available in this area. This bathroom should be large enough to have witness sample collection.

How many visitation rooms are required? How many people could be in each room? Or follow FGI guidelines.

RESPONSE: FOLLOW FGI GUIDELINES Ideally visitation rooms could include a table with four to five chairs in otherwise comfortable seating or a couch. These could also be utilized for casual consultation rooms or small group discussions.

Will seclusion rooms be required, if so, how many? Or follow FGI guidelines

How many patients should be accommodated in the group dining facility at any given time?

RESPONSE: THE TOTAL PROJECT COST FOR THIS PROJECT IS ANTICIPATED TO BE \$1.5 MILLION. THE \$42 MILLION WAS A CARRY OVER FROM THE ORIGINAL JUSTICE CENTER/JAIL RENOVATION PROJECT.
