# PROSECUTOR CHARGES COUPLE WITH NEGLECT RESULTING IN DEATH

*Muncie Indiana* – On today's date the Prosecuting Attorney Eric M. Hoffman formally charged Jacob C. Grayson (DOB 1/5/1994) with the following criminal offenses:

- Count 1: Neglect of a Dependent Resulting in Death, a Level 1 Felony.
- Count 2: Neglect of a Dependent Resulting in Death, a Level 6 Felony.
- Count 3: Neglect of a Dependent Resulting in Death, a Level 6 Felony.
- Count 4: Neglect of a Dependent Resulting in Death, a Level 6 Felony.

Prosecutor Hoffman also charged Kimberly D. Grayson (DOB 11/15/1994) with the following criminal offenses:

The charges are pending in the Delaware Circuit Court No. 5. The Honorable Judge Thomas A. Cannon Jr. will set the cases for initial hearings. Copies of the charging information and Affidavit of Probable Cause that were filed with the Court are attached.

Pursuant to Indiana law:

- A Level 1 Felony is punishable by 20 40 years in prison and up to a \$10,000 fine.
- Each Level 6 Felony is punishable by 6 months 2.5 years in prison and up to a \$10,000 fine.

It is important to remember that any accusation that someone has committed a crime, an arrest and/or the filing of a criminal charge is simply an allegation and is not evidence of guilt. All suspects are presumed innocent unless and until proven guilty beyond a reasonable doubt at trial. The ethical rules for prosecutors in Indiana prohibit further comment on this matter. At this time, there will be no further comment.

Upon arrival 5-year-old CG was located with a severe gunshot wound to the head. She was later pronounced deceased at Ball Memorial Hospital. Initial 911 caller, Jacob Grayson, advised that 6 year old SG got a gun out of his safe and shot his sister, CG. Jacob and Kimberly Grayson are the biological parents of both SG and CG.

I conducted a forensic interview with SG at the child advocacy center. I am trained and certified as a forensic interviewer by the Zero Abuse Project. In his interview SG stated that he got a black gun out of a safe in his mom and dad's bedroom while his mom napped. SG said the safe was located on a dresser in the parents' bedroom. SG stated the key was in the key hole and he simply turned it, pushed on the door, and it opened. He advised he accidentally shot CG while playing with the gun.

Jacob Grayson was interviewed at Muncie Police Department. He acknowledged and waived his rights. Jacob stated in his interview that SG has accessed his safe in the past. After SG

accessed the safe in the past, Jacob moved it to the other side of the dresser which SG could reach, rather than placing it somewhere inaccessible to a small child. He also stated that the key to the safe may have been left in the key hole on the safe. Jacob advised that there are two firearms that he keeps in the safe, he stated each gun had a loaded magazine inserted. Jacob also said that he has taken SG to a shooting range before and showed him how to shoot a gun.

The living conditions in the home were deplorable. There was food, trash, animal feces, and furniture strewn throughout the house. The children's beds were mattresses on the floor with no sheets or blankets. Both mattresses had various stains on them. The walls of the home appeared to have feces smeared on them in multiple places.

Jacob Grayson is charged with Neglect of a Dependent Resulting Death (Level 1 Felony) for placing CG in a situation that endangered her life or health which resulted in her death. He is charged with Neglect of a Dependent (Level 6 Felony) for allowing SG unsupervised access to a firearm. He is also charged with two counts of Neglect of a Dependent (Level 6 Felony) for maintaining inhabitable housing conditions for CG and SG.

also stated that she took a nap this afternoon, but estimated she only slept five minutes. Kimberly was in her bed in her bedroom, where the safe was located. The safe was on a very low dresser that 6-year-old SG can easily reach. Kimberly advised that SG must have accessed the safe and obtained the firearm while she napped. Kimberly also acknowledged that the key which unlocks the safe may have been left in the key hole on the safe. Kimberly said that she and Jacob Grayson have taken SG to a shooting range before and showed him how to shoot a handgun.

The living conditions in the home were deplorable. There was food, trash, animal feces, and furniture strewn throughout the house. The children's beds were mattresses on the floor with no sheets or blankets. Both mattresses had various stains on them. The walls of the home appeared to have feces smeared on them in multiple places.

Kimberly Grayson is charged with Neglect of a Dependent Resulting Death (Level 1 Felony) for placing CG in a situation that endangered her life or health which resulted in her death. She is charged with Neglect of a Dependent (Level 6 Felony) for allowing SG unsupervised access to a firearm. She is also charged with two counts of Neglect of a Dependent (Level 6 Felony) for maintaining inhabitable housing conditions for CG and SG.
