

## JURY CONVICTS ANOTHER DRUG DEALER OF DEALING IN A CONTROLLED SUBSTANCE RESULTING IN DEATH

Muncie Indiana – Today a Delaware County jury deliberated for a little over an hour before convicting Vera R. Morgan (DOB 1/20/1989) of Dealing in a Controlled

Substance Resulting in Death, a Level 1 Felony. The jury also found Morgan to be an Habitual Offender in that she has accumulated at least 2 prior unrelated felony convictions – specifically Fraud, a level 6 felony, Possession of a Narcotic Drug, a Level 6 Felony, and Residential Entry, a Level 6 Felony. A copy of the Affidavit for Probable Cause for Arrest is Attached. The Honorable John M. Feick, Judge of the Delaware Circuit Court No. 4 set sentencing for October 19, 2022 at 9:00 am. Pursuant to Indiana law:



Vera Morgan

- A Level 1 Felony is punishable by 20 40 years in prison and up to a \$10,000 fine.
- The Habitual Offender Enhancement can add an additional 6 − 20 years to the total sentence.

After the verdict was returned, Delaware County Prosecuting Attorney Eric Hoffman said "This conviction marks the third time this year our office has successfully prosecuted a defendant for Dealing in a Controlled Substance Resulting in Death. Despite what some may think, dealing drugs is a violent crime. This conviction should send a crystal clear message to drug dealers: if you deal narcotics in Delaware County and your customer overdoses and dies, you will be prosecuted and you will be held accountable. Stop selling your poison in our community. I am proud of Chief Deputy Zach Craig and Deputy Prosecutors Andrew Ramirez and Jagen Arnold for their hard work and dedication in this case."

## AFFIDAVIT OF PROBABLE CAUSE FOR ARREST WITHOUT WARRANT

COMES NOW, **Matthew Berger**, a police officer of the Muncie Police Department, and being first duly sworn upon oath, deposes and says that the following described person was arrested, without Warrant, upon the charge(s) and circumstances hereinafter stated, and makes this affidavit for the purpose of establishing probable cause for said arrest.

CHARGE 1: Dealing in a Narcotic Drug resulting in Death a level 1 FELONY

The basis and reasons why this officer believes that said arrestee committed the aforesaid offense (s) are as follows:

On 10/20/2020 I was assigned a death investigation. The death was the result of Mandy Hart overdosing. The night or morning of the overdose Officers were able to speak with Hart's boyfriend Matt Stockton and get Mandy Hart's phone and passcode. Stockton explained that they bought drugs from Vera Morgan and Michael Schoeff. Stockton showed facebook messages between Hart and Morgan. Those messages were photographed that night and the phone was collected so it could be downloaded and anylyzed. On 10/28/2020 Stockton came to City Hall for a statement. Stockton explained the entire day from the time of picking Hart up with his father at Harbor Lights in Indianapolis, In. Stockton explained that Mandy had her mind made up to get dope when she got to Muncie, In before they even picked her up. Stockton stated when they got home Mandy contacted Vera Morgan in attempt to get dope from her. Stockton stated that Mandy and him eventually met Vera Morgan and Michael Schoeff at the gas station located at Port and Hoyt St. Stockton stated they were in a black vehicle, sedan style, later determined to be a Black Ford Fusion returning to Vera Morgan with Indiana license plate DPC293. Stockton advised he watch Mandy hand Morgan \$40.00 in U.S. Currency and Vera in return hand Mandy a small clear bag containing what they thought was heroin. Stockton explains that it was raining and Vera offered them a ride to near Stockton's residence. They took the ride and was dropped off near 9th and Hoyt. Stockton explained that the two walked back to his house and began using the dope which he estimated to be about a quarter of a gram. Stockton stated after they split one shot Mandy overdosed and he had to help bring her back. Stockton stated after that she forgot it had happened and they both took another shot. Stockton stated he passed out and when he woke up found Mandy not breathing. Stockton stated the dope came from Vera Morgan that they used that night and that they did not purchase from anyone else.

Schoeff and Morgan were both located and taken to Muncie City Hall where I spoke with them. At approx. 1:23pm I read Morgan her rights acknowledgment and waiver. Morgan stated she understood her Statement of rights and signed. I then read Morgan her waiver of rights. Morgan stated she understood and signed at approx. 1:25pm. Morgan denied giving Hart heroin that night, however stated they did give them a ride to 9<sup>th</sup> and Hoyt from the Port and Hoyt gas station. Morgan would not admit that she sold Heroin to them that night, but admitted to giving them Heroin for Hart's birthday week. It was later determined that Morgan and Schoeff sold Hart and Stockton and quarter gram for \$40.00 and they used it at Schoeff's residence located at 1209 W. 17<sup>th</sup> St. Morgan admitted to giving them heroin that night, but refused to admit any guilt in giving her the heroin that killed her even though the two talked about it in facebook messages. Morgan went as far as saying she didn't even have any on her to sell, however in facebook messenger she told Hart she did prior. Which was only a 20 minute difference in time.
