The agreement is an option to purchase, at the end of the agreement, with a total value to Delaware County of \$3,500,000. This will go into the Tax Increment Fund (TIF) and its more than double the contribution towards the building of the rail spur.

Mr. Bookout said once the agreement is signed, Mr. Bookout said his understanding is that construction will begin immediately.

Councilmember Hughes congratulated Mr. Bookout and the Commissioners for removing the liability from Delaware County and adding this as an asset to Delaware County.

*Whereas*, the Board of Commissioners conducted a public hearing on April 17, 2023 with regard to the lease and option to purchase the real estate and approved said lease and option; and

*WHEREAS*, having considered the information provided the County Council hereby desires to make a final determination on the lease with an option to purchase the identified real estate parcels.

*IT IS THEREFORE RESOLVED BY THE COUNTY COUNCIL OF DELAWARE COUNTY, INDIANA THAT:*

**SECTION 1.** Having received and considered the lease with an option to purchase from the Board of Commissioners, a copy of which is attached to this Resolution and considered same.

**SECTION 2.** The lease with an option to purchase of the identified parcel shall be approved by the County Council.

**SECTION 3.** The President of the Board of Commissioners is hereby authorized to execute all documents necessary to carry out the terms of this Resolution.

MURSIX REVENUE BOND  
ORDINANCE 2023-013

MOTION: Councilmember Whitehead made a motion to approve Ordinance 2023-013, Mursix Revenue Bond.

Mr. Bookout introduced Mr. Dave Nie.

Mr. Nie, Ice Miller Bond Attorney, provided an explanation, per the request of Old National Bank, Delaware County and Mursix to amend the 2014 bond. The rate on that bond is tax-exempt, based on the Libor index. Libor is being retired in June 2023, back in 2014, nobody in the world would have thought that this would go away. This is an administrative amendment to the bond. This is built in mechanics to tie the variable rate to a new interest rate to a benchmark index. Council is a party to the bond documents and amendment.

Mr. Bookout asked for consideration of the rules being suspended on Ordinance 2023-013, Mursix Revenue Bond.

Mr. Ben Freeman, Council Attorney, said statutorily the motion on the first reading must be approved unanimously and then hold a vote on the underlying bond itself.

ORDINANCE NO. 2023- 013

ORDINANCE OF DELAWARE COUNTY, INDIANA, AUTHORIZING AND APPROVING CERTAIN ACTIONS AND DOCUMENTS IN CONNECTION WITH THE AMENDMENT OF THE DELAWARE COUNTY, INDIANA ECONOMIC DEVELOPMENT REVENUE BONDS, SERIES 2014 (MURSIX CORPORATION PROJECT)

**WHEREAS**, the County of Delaware, Indiana (the "County"), is a political subdivision of the State of Indiana and by virtue of Indiana Code §§ 36-7-11.9 and 36-7-12 (collectively, the "Act"), is authorized and empowered to adopt this ordinance (this "Ordinance") and to carry out its provisions; and

**WHEREAS**, on November 25, 2014, pursuant to the Trust Indenture, dated as of November 1, 2014 (the "Original Bond Indenture"), between the County and Old National Trust Company, as Trustee (the "Trustee"), and as provided for in Ordinance No. 2014-013 of the County, adopted on June 24, 2014 and attached hereto as Attachment A (the "Original Bond Ordinance"), the County issued its Delaware County, Indiana Economic Development Revenue Bonds, Series 2014 (Mursix Corporation Project) in an original principal amount of \$4,220,000 (the "Bonds") and lent the proceeds of the Bonds to Mursix Corporation (the "Borrower") pursuant to a Loan Agreement, dated as of November 1, 2014 (the "Loan Agreement") between the County and the Borrower; and

**WHEREAS**, the Bonds were purchased by Old National Bank (the "Purchaser") pursuant to the Bond Purchase Agreement dated November 25, 2014 (the "Original Bond Purchase Agreement") among the County, the Borrower and the Purchaser; and

**WHEREAS**, the Bonds bear interest at the Tax-Exempt Interest Rate (as defined in the Original Bond Purchase Agreement) which uses an interest rate based on the London Interbank Offered Rate ("LIBOR"), a recognized global reference rate; and

**WHEREAS**, the ICE Benchmark Administration (IBA) has stated it intends to cease publication of LIBOR after June 30, 2023; and

**WHEREAS**, in anticipation of LIBOR's retirement, the Purchaser and the Borrower have agreed to certain amendatory language to the Original Bond Indenture and the Original Bond Purchase Agreement to provide for a new index upon with the interest rate for the Bonds will be calculated; and

**WHEREAS**, Section 9.2 of the Original Bond Indenture provides that the terms and provisions of the Bonds and the Original Bond Indenture may be modified or altered in any respect with the consent of the Borrower, the County, the Trustee and the Bondholders of all of the Bonds then outstanding; and

**WHEREAS**, the County and the Trustee desire to amend the Original Bond Indenture, with the consent of the Borrower and the Purchaser (as the Holder of 100% of the Bonds
