PROSECUTOR CHARGES TARRON H. CONWELL WITH ATTEMPTED MURDER OF THREE SHERIFF'S DEPUTIES

Muncie Indiana – On today's date the Prosecuting Attorney Eric M. Hoffman formally charged Tarron H. Conwell (DOB 12/29/2003) with the following criminal offenses:

Count 1: Attempted Murder, a Level 1 Felony

Count 2: Attempted Murder, a Level 1 Felony

Count 3: Attempted Murder, a Level 1 Felony

Count 4: Unlawful Carrying of a Handgun, a Class A Misdemeanor

Count 5: Resisting Law Enforcement, a Level 6 Felony

It is important to remember that any accusation that someone has committed a crime, an arrest and/or the filing of a criminal charge is simply an allegation and is not evidence of guilt. All suspects are presumed innocent unless and until proven guilty beyond a reasonable doubt at trial.

The charges are pending in the Delaware Circuit Court No. 1. The Honorable Judge Judi L. Calhoun will set the case for an initial hearing. Copies of the Charging Information and Affidavit of Probable Cause that were filed with the Court are attached.

Pursuant to Indiana law:

- Each Level 1 Felony is punishable by 20 40 years in prison and up to a \$10,000 fine.
- A Level 6 Felony is punishable by 6 months 2.5 years in prison and up to a \$10,000 fine.
- A Class A Misdemeanor is punishable by up to 1 year in jail and a \$5.000 fine.

The ethical rules for prosecutors in Indiana prohibit further comment on this matter. At this time, there will be no further comment.
