MOTION: Councilmember Flanagan made a motion to approve agenda, as presented.

COUNTY GENERAL

Ms. Tonya Dunsmore, read aloud requests.

MOTION: Councilmember Whitehead made a motion to approve Auditor transfer (see below).

SECOND: Councilmember Flanagan

Councilmember Whitehead asked why this is needed.

Mr. Ed Carroll, Auditor, said he is not asking for an appropriation only a transfer. If this does not happen then the person would not have a job.

Councilmember Mochal asked why would this person not have a job. Councilmember Mochal said he remembers it happening once before.

Mr. Carroll said the person is coming from the Clerk's office and will be the Exemption Clerk in the Auditor's office. If the person is not hired, no one would be at the front desk to do exemptions. The \$5,000 would cover until the end of March 2024 because the person leaving has time that started again in January.

President Piper agreed that this had happened before in the Treasurer's office, due to a death, however, it was only for a few hundred dollars.

Ms. Tonya Dunsmore, Settlement Clerk, said the person leaving has time that has to be paid out, however, the person retiring will not be in the office.

January 3, 2024 Council meeting

Mr. Rick Spangler, Clerk, said this happens a lot when employees leave, in January employees earn their time. This is in the handbook. Mr. Spangler said this will continue to happen more and more the longer the employee is at their job.

President Piper said so the employees get vacation up front in January. This does not work that way at her job.

Continued conversation regarding how this works for other Councilmembers in their jobs, when and how they earn vacation, pay backs if and when they leave.

MOTION: Councilmember Whitehead made a motion to approve Clerk 125 transfer (see below).

Mr. Rick Spangler, Clerk, explained the requests. Mr. Spangler said a loss of three of five filing clerks is a huge problem, one filing clerk is assigned to each court. Many are leaving, due to the fact of financial reasons.

One employee that currently works for the Courts is willing to come back to the filing office, however, that person does not want to take a pay cut. Mr. Spangler said he should have enough money in part-time even taking the \$3,000 out. Mr. Spangler said he and his employees are coming to budget next year to fight for equal pay/equal scale for the Clerk's office. The pain needs to be shared.

Councilmember Mochal said he is disappointed that a job study has even occurred. Employees are going to be more disappointed when they see that they are underpaid and the fact of the matter is "so what", when the county cannot pay the employee more.

Mr. Spangler said it is time to balance the pain. It is time for new ideas/plans and to not let the bullies win.

Councilmember Kantz agrees with Councilmember Mochal but also agrees with Mr. Spangler. Everything should be considered on their own merit as in any business. The \$3,000 should be taken out of trusting the Elected Official, Mr. Spangler knows what he needs.

Councilmember Hughes said the Filing Clerk is very important and is the start of the court process. Mr. Spangler found money and he is willing to defer to his judgement.

Mr. Spangler said the longevity of employees are around 15 years.
