**AN ORDINANCE TO AMEND AN ORDINANCE  
REGULATING TRAFFIC ON CERTAIN PUBLIC STREETS IN  
DELAWARE COUNTY**

**BE IT ORDAINED:** By the Board of County Commissioners, Delaware County, Indiana that an ordinance enacted prior to this day, September 15, 2008, entitled "Traffic Ordinance" is hereby amended as follows:

**Title 5, Chapter 2, Sections 6, are to be amended as follows:**

*Remove*  
Item No. 1. ~~The parking of and the size and weight restrictions of vehicles as set out in said Chapter 2 by Ordinance No. 1984-21 shall apply to all public streets within the town of Shideler, located in Union and Hamilton Townships, Delaware County, Indiana.~~

**Title 5, Chapter 4, Section 5, is to be amended as follows:**

Item No. 2. There shall be a 1-way stop on C.R. 200 West, at its intersection with Eaton Wheeling Pike, located in Union Township, Delaware County, Indiana.

Item No. 3. There shall be a 2-way stop on C.R. 200 West, at its intersection with C.R. 1000 North, located in Union Township, Delaware County, Indiana.

Item No. 4. There shall be a 2-way stop on C.R. 200 West, at its intersection with C.R. 900 North, located in Union Township, Delaware County, Indiana.

Item No. 5. There shall be a 1-way stop on C.R. 200 West, at its northern and southern intersections with C.R. 800 North, located in Union Township, Delaware County, Indiana.

Item No. 6. There shall be a 3-way stop at the intersection of Moore Road and Weir Drive, in Farmington Addition, located Hamilton Township, Delaware County, Indiana.

Item No. 7. There shall be a 4-way stop at the intersection of N. Walnut Street and C.R. 1200 North, located in Union Township, Delaware County, Indiana.

Item No. 8. There shall be a 4-way stop at the intersection of N. Walnut Street and C.R. 900 North, located in Union Township, Delaware County, Indiana.

Item No. 9. There shall be a 1-way stop on Shideler Street, at its intersection with C.R. 800 North, within the town of Shideler, located in Union Township, Delaware County, Indiana.

Item No. 10. There shall be a 2-way stop on Interurban Street, at its intersection with C.R. 800 North, within the town of Shideler, located in Union and Harrison Townships, Delaware County, Indiana.

Item No. 11. There shall be a 1-way stop on Interurban Street, at its intersection with Chestnut Street, within the town of Shideler, located in Harrison Township, Delaware County, Indiana.

Item No. 12. There shall be a 1-way stop on Interurban Street, at its intersection with Ashcraft Street, within the town of Shideler, located in Union Township, Delaware County, Indiana.

Item No. 13. There shall be a 2-way stop on Chestnut Street, at its intersection with C.R. 800 North, within the town of Shideler, located in Union and Harrison Townships, Delaware County, Indiana.

**Title 5, Chapter 4, Section 8, is to be amended as follows:**

Item No. 14. There shall be a 40 mph speed limit on C.R. 200 West, between Eaton Albany Pike and C.R. 800 North, located in Union Township, Delaware County, Indiana.

Item No. 15. There shall be a 40 mph speed limit on Eaton / Wheeling Pike, between the west town limits of Wheeling and C.R. 500 West, located in Washington Township, Delaware County, Indiana.

Item No. 16. There shall be a 20 mph speed limit on all streets within the town of Shideler, including Shideler Street, Ashcraft Street, Interurban Street, Chestnut Street and C.R. 800 North between S.R. 3 North and C.R. 175 East, located in Union and Harrison Townships, Delaware County, Indiana.


Item No. 17. The County Highway Department of Delaware County, Indiana, is hereby authorized to erect appropriate signage pursuant to the Indiana Manual on Uniform Traffic Control Devices.

Item No. 18. The penalty for violation of this ordinance shall be as herein setforth in Article XVI, Section 16-1.


Item No. 19. This ordinance shall be in full force and effect from and after its passage and publication.


