WHEREAS, the Delaware County Board of Aviation Commissioners (hereafter "Board") currently has four (4) members; and

WHEREAS, the County Commissioners desire to appoint a fifth member as permitted by IC 8-22-2-1 in order to avoid tie votes and to give the Board broader representation; and

WHEREAS, the statute requires political balance on the Board by mandating that no more than three (3) members may be of the same political party; and

WHEREAS, political party affiliation should be determined by the ballot selected by the Board member at the last primary election in which he/she voted;

NOW, THEREFORE, BE IT ORDAINED that a fifth member shall be added to the Board of Aviation Commissioners pursuant to IC 8-22-2-1, that this fifth member shall be added with an initial term of four (4) years, effective from January 1, 2007, and that the Board shall have no more than three (3) members of the same political party, with party affiliation to be determined by the ballot selected by the Board member at the last primary election in which he/she voted.
