## AN ORDINANCE TO AMEND AN ORDINANCE REGULATING TRAFFIC ON CERTAIN PUBLIC STREETS IN DELAWARE COUNTY

**BE IT ORDAINED**: By the Board of County Commissioners, Delaware County, Indiana that an ordinance enacted prior to this day, , 2009, entitled "Traffic Ordinance" is hereby amended as follows:

## Title 5, Chapter 4, Section 8, is to be amended as follows:

- Item No. 1. There shall be a 30 mph speed limit on C.R. 25 West, between SR 28/US 35 West and Royerton Road, located in Hamilton Township, Delaware County, Indiana.
- Item No. 2. There shall be a 30 mph speed limit on Fuson Road, between S. Walnut Street and S. Madison Street, located in Center Township, Delaware County, Indiana.
- Item No. 3. There shall be a 45 mph speed limit on Fuson Road, between S. Madison Street and Old State Road 67, located in Center Township, Delaware County, Indiana.
- Item No. 4. There shall be a 40 mph speed limit on Fuson Road, between Old State Road 67 and Hoyt Avenue, located in Center Township, Delaware County, Indiana.
- Item No. 5. There shall be a 45 mph speed limit on Old State Road 67, between Fuson Road and C.R. 350 South, located in Monroe Township, Delaware County, Indiana.
- Item No. 6. There shall be a 30 mph speed limit on Lee Pitt Road, between SR 332 West and C.R. 300 North, located in Harrison Township, Delaware County, Indiana.
- Item No. 7. There shall be a 40 mph speed limit on C.R. 925 West, between C.R. 300 North and C.R. 700 North, located in Harrison Township, Delaware County, Indiana.
- Item No. 8. The County Highway Department of Delaware County, Indiana, is hereby authorized to erect appropriate signage pursuant to the Indiana Manual on Uniform Traffic Control Devices.

Item No. 9. The penalty for violation of this ordinance shall be as herein setforth in Article XVI, Section 16-1.
Item No. 10. This ordinance shall be in full force and effect from and after its passage and publication.
