

DELAWARE COUNTY HEALTH DEPARTMENT MISSION STATEMENT

The Delaware County Health Department is organized for the purpose of health promotion and communicable disease prevention for the entire Delaware County community. Risk reduction and public health awareness are directed toward individuals, of all ages, to achieve optimal health. The department will facilitate programs that educate, enforce, and provide services for the promotion and maintenance of a healthy environment in Delaware County.

The mission statement was approved at the October 10, 1996 Board Meeting.

Prologue



PROLOGUE 2008

2008 has been another eventful year for the Delaware County Health Department. Funding for operations are becoming more challenging as time proceeds. Due to changes in property tax collections, funds are diminishing for all areas of local government, including public health. The Delaware County Council has been supportive of funding for this department, but funds are being reduced as reflected for the 2009 budget year. Funding was reduced in several areas, including the loss of an environmental position within the department. In early 2008, it was necessary to borrow \$300,000 to sustain operations for the year. These funds are paid back through property tax collections at the end of the year. The department did receive tobacco settlement funds as in past years. These funds were utilized to aid in funding the YMCA KIDZ Marathon, Gateway Clinic, Minority Tobacco Free Coalition, Future Choices, REACH Center, and the Tobacco Free Coalition. The Board of Health reviews all requests for funding to determine the impact on public health issues and the Health Needs Assessment completed in 2006. These investments in public health practices to other agencies and coalitions demonstrate the effectiveness of working with our partners within the community to make Delaware County a healthier place to live and work.

The Website developed by the county and maintained by our Environmentalist, has had a tremendous impact on reaching the community and others with public health information. Clinic schedules, health education information, food service inspections, applications for services and other pertinent information are readily available. The site reveals thousands of visits to obtain information.


Preparedness continues to be at the forefront for public health and other first responders. A pandemic exercise was conducted in Jennings County for District 6 in November. District 6 consists of thirteen counties including Delaware, working together to accomplish planning and procedures for protecting the public from pandemics, terrorist attacks, and natural disasters. This is a large undertaking by all public health departments in the state as well as other first responders, hospitals, and local governments.

The department received a grant from the EPA for an ASTHMA Program. The grant provides for a part time person to work with families with children diagnosed with asthma. Cases are referred from Clinics, the hospital, and physicians. The staff member works with the families to identify triggers for asthma attacks. Education is provided to assist the families to eliminate triggers within the child's environment. Approximately seven percent of the population is afflicted with asthma. This is a new program that began at the end of the year.

Challenges in the health of the population continue to unfold. The country has too many people who lack health insurance, a health care provider and access to preventive health services. Although health professions have developed many life saving procedures, preventive health practices continue to be under funded. Indiana ranks last in funding for public health in the nation. This is unacceptable as a state and must be addressed. Prevention measures have demonstrated to be an effective method to improve the health of individuals and communities.

Appropriate public health practices should be at the forefront to improve the health of the population as a whole. Public Health, health care providers, universities, hospitals and communities must work together to improve the health of the population. The cost of health care, which continues to rise above the rate of inflation, must be addressed. Health prevention measures if taken seriously could have a significant positive impact on the health and well being of not only Delaware County citizens, but the country as a whole. Please review this annual report to read about the public health programs provided by this department. Contact representatives of the department with any questions. The Board of Health conducts monthly meetings that are open to the public. These meetings are held in the evening at the county building. The public is encouraged to attend and participate in discussions to enhance public health practice in Delaware County.

Environmental Division



ENVIRONMENTAL DIVISION

The Environmental Division of the Delaware County Health Department investigated 538 new complaints in 2008. The areas with the greatest number of complaints were: Housing, Outside Trash and Debris, Sewage, Vector Control, and Mold. Sewage complaints continue to be of concern in neighborhoods and housing developments not serviced by sewers.

In 2008, the environmental division continued to work through the judicial system to gather compliance. The revamped paper work shortens the legal process and puts more responsibility on the violator to prove their case. The environmental division hired Claude Chandler. Claude Chandler left in October 2008. Christiana Mann joined the environmental division in 2008. Christiana became a CPO and is the Lead Risk Assessor for the department. Christiana also is the Web coordinator.

ENVIRONMENTAL COURT

Without court intervention, it would be impossible to effectively enforce environmental laws. The Environmental Division thanks the Honorable Judge Daily and his Court Staff for their assistance in this matter. We would like to offer our appreciation to our attorney Donald Dunnuck, without his efforts our cases would not be before the courts.

SEWER PROJECTS

The Tanglewood Addition is ready to go under construction. No new projects were brought online in 2008.

The health department continues to work with the Delaware County Regional Sewer District to bring projects to the Cowen and Desoto areas. In 2009, the health department will begin to present information on Decentralized systems, in hopes to address areas of concern.

ON-SITE SEWAGE DISPOSAL SYSTEMS

During 2008, there were 32 applications made to install on-site sewage disposal systems in Delaware County. There were 22 permits issued. All applications require at least one on-site visit and soil profiles for both new and repair. However, most sites require two or more visits before all parties agree upon an acceptable site. There is also one pre-installation meeting and at least one final inspection. State wide we are seeing a tremendous drop in construction. It is getting more difficult to get property owners to repair failing systems. The health department is struggling with how to handle these issues and onsite sewage disposal.

The health department hosted a workshop for the installers and designers in Delaware County. We had 39 people attend the workshop that focused on design requirements.

All new construction and repair systems require a certified soil scientist to perform the soil profile. There were 29 registered installers for 2008.

WELL PERMITS

Well permits must be obtained for all drinking water wells, new or repairs. A permit must also be obtained to repair or replace a pump. Each permit provides for the well to be tested for bacterial quality. Each subsequent testing must be done at the expense of the owner in case the first test shows positive for coliform bacteria. The following is a look at the year 2006:

TRASH HAULERS PERMITS

Trash hauling permits were issued for 123 vehicles from 7 companies in 2008. There were no complaints against any trash haulers.

SWIMMING POOL REPORT

Delaware County has 41 public/semi-public swimming pools. Twenty-three (23) of these pools are seasonal and 17 operate year round. Swimming pools/spas are inspected three (3) times a year. Weekly water samples must be submitted to a certified laboratory for bacterial testing. Two inspectors, Christiana Mann and Christine Stinson, are Certified Pool Operators. The department hosted a training program in the spring for pool operators. Thirty two (32) men and women attended this program. One semi-annual pool permanently closed and was filled in. On December 19, 2008 the "Virginia Graeme Baker Pool and Spa Safety Act" was enacted, requiring all pools and spas to come into compliance with anti-entrapment devices or systems that comply with ASME/ANSI A112.19.8 performance standards.

HOME LEAD INSPECTIONS

In the year 2008, the Environmental Division continued to work with the Nursing Division to bring the program in line with the mandated requirements from the Indiana State Department of Health. Jammie Bane and Christiana Mann are certified Lead Risk Assessor/Inspectors. Mr. Bane left Delaware County Health Department in May to pursue another career, and Ms. Mann took over the referred cases. In home visits were conducted with paint chip sampling and dust wipe sampling. This also includes literature review with the parents or guardians and education on cleaning and keeping dust levels down in and around the home.

WEST NILE/MOSQUITO CONTROL.

Three Environmental Specialists, Christine Dely-Stinson, Christiana Mann and Claude Chandler have their Category 8 Certification from the State Chemist Office. The Category 8 Certification is required in order to apply chemicals for mosquito control.

Delaware County switched the product for adulticiding to Duet this year. Duet has an agitating agent that makes the mosquitoes more active and attracts them to the product, therefore, giving a more effective effort in mosquito control. This year the health department worked with the Town of Albany to improve their program. The health department sold the town their older ULV machine and bought a newer machine. This allowed the health department to have a machine that allows for faster application and more accurate application. It allowed the Town of Albany to stop applying Malathion mixed with Diesel Fuel. The Town of Albany now uses the There are a total of eight routes that are same product as Muncie Sanitary District, Anvil. covered by the environmental division. Muncie Sanitary Division handles the spraying of the city of Muncie.

Due to the cost of shipping, the health department did not send any birds in for testing.

Delaware County had 2 positive mosquito catches in Muncie in 2008. We do not collect mosquitoes for collections, the collections were done by ISDH.

No horses tested positive for West Nile in Delaware County in 2008.

There were no human cases of West Nile in Delaware County reported. There were 3 cases reported statewide.

RABIES

In 2008, there were 279 animal bites reported to the Delaware County Health Department. Most of the biters were placed under a 10-day quarantine/confinement period and observed for symptoms of rabies. The other biters were put down and their heads submitted to the Indiana State Board of Health for rabies testing. No animals tested positive for rabies in Delaware County.

TATTOO/PIERCING PROGRAM

Each tattoo establishment and each tattoo artist must obtain a permit. These permits are for one year only and must be renewed annually. All artists must complete blood borne pathogens training, and show proof of certification. Establishments are inspected three times a year. In 2008 the Delaware County Health Department was forced to take legal action against Claire's and Icing's for non-compliance. The court ruled in favor of the Health Department. One additional change has been made to sanitation requirements. In accordance to IAC 1-4-8, biological indicators for heat sterilization are now required weekly. In the past it was required monthly. The Delaware County Health Department has asked that each establishment provide lab results in a timely manner for their office file. Three establishments did not comply. One closed permanently; one complied only after an abatement order was issued; and another establishment was ordered closed, and reopened after deciding to use prepackaged/disposable equipment.

SPECIAL PROJECTS

Christine Dely-Stinson and Christiana Mann were both accepted into and are attending the Mid American Regional Public Health Leadership Institute (MARPHLI). This is a year long program designed to develop and enhance Public Health Leaders in local communities.

SUMMARY

The environmental division faced many changes and challenges in 2008. In October Claude Chandler left our department to move to another state. Due to budgetary constraints one (1) position was cut; and due to a hiring freeze one (1) additional position was not able to be filled. As the economy is getting tough, the need for public health is ever increasing. As budgets are cut and positions are vacant, the need to streamline programs and restructure current SOP is necessary. The environmental division will continue to deliver the highest quality of work in the most efficient manner, while looking for different ways to protect the public health of Delaware County.

Food Division



FOOD DIVISION

The Food Division staff in 2008 has continued to acquire training in maintaining a quality food protection program. One inspector has started the required re-certification training with the Indiana State Department of Health for Standardization. The Standardization certification requires multiple training days every year to maintain standardization. Also the newest inspector to the staff has successfully completed a nationally recognized safe food handler certification as an instructor of the course and a proctor of the examination of the testing phase of the Certified Food Handler course.

The food handlers' certification program established by the State of Indiana has proven to be beneficial to the consumer. This requires that a person qualified in food service safety be on the staff of each food service facility, including temporary food service operations.

At least two inspections of each food service facility in Delaware County have been completed this year. If critical violations are noted during an inspection, a follow-up inspection is conducted to assure compliance with the code. All consumer complaints on facilities are investigated. This department encourages the public to be interactive with this office and report any conditions allowing unsafe food handling practices. Staff distributed Operator Response Forms to all establishments during the exit interview of the inspection process. There was a marked increase in compliance factor observed when the person in charge submitted a plan of action in written form. Those voluntary records are attached to the inspection records after they are received and reviewed.

The records of food inspections are public domain. The public is welcome to come to this office to review any food service report. In 2007, Delaware County implemented an internet site which allowed inspection reports to be posted on the web for the public to view. As of March 14, 2009, 116,405 inspection reports were viewed on the County Web site. Also the Muncie Star/Press does a weekly article in the newspaper about the inspections completed.

The use of laptop computers in the field for printing out of the inspection reports has been very beneficial to the department and to the establishment. The response from the consumer and the local food industry has been very positive. Inspection reports are legible and easier for the consumer to read. The posting of the inspection report at the establishment and the scanned inspection reports available on the web site, has led to a greater importance to food safety in Delaware County.

The Muncie Star/Press reported food establishments around the country were having a difficult time in staying in operation due to economic hardships. In 2008, Delaware County experienced just the opposite. In 2008, there was a large increase in the number of establishments that opened as a new establishment, remodel an existing establishment, or a complete demolition and building of a new structure for the existing business. The department also experience very few closures for going out of business.

The Food Division has always taken the position of enforcing sanitation codes regulating the food service industry in Delaware County. The division makes every effort to ensure the food consumed by residents and visitors to the county are safe and wholesome. This is applicable to not only year around retail businesses, but temporary facilities found at festivals as well.

Health Education Division



HEALTH EDUCATION

In 2008, the health education division experienced a variety of changes and improvements. The health education division remains committed to providing programs aimed at improving the quality of life for the residents of Delaware County.

BLACK EXPO

One health educator is on the planning committee for the Health, Employment and Information Community Fair. This committee holds an annual health fair that is the largest in Delaware County. It consists of a large variety of free health screenings, job openings in the community and information on various agencies in the area. The Muncie Black Expo planning committee is a collaboration of several agencies that work together to make the community event successful.

DELAWARE COUNTY SAFE KIDS COALITION

The Health Department remains the lead agency for the Delaware County Safe Kids Coalition and continues to provide a coordinator for the coalition. The coalition distributed approximately 58 bicycle helmets to children in need. The coalition inspected a total of 39 child safety seats at car seat clinics and replaced a total of 16 child safety seats.

HEALTHY MOTHERS HEALTHY BABIES (HMHB)

One health educator serves as the chair on the HMHB committee. This committee focuses on reducing pregnancy among teens. Healthy Mothers Healthy Babies is a collaboration of agencies that work together to provide information to help teens and their parents with teen pregnancy issues.

HELPING HANDS HEALTH FAIR

The Delaware County Health Department offered a health fair that addresses the needs of the uninsured, underinsured, those in transitional housing and the homeless, through education and screenings. This event was held at the YWCA, about 250 individuals were served. The Delaware County Health Department was pleased to have played a major role in such a worthwhile event.

MAYOR'S ADVISORY COMMITTEE FOR HEALTH EDUCATION

The health education division continues to participate in this committee that meets every other month. The health department, on behalf of the MACHE committee, tapes 30 minute educational programs. MINORITY TOBACCO FREE COALITION OF DELAWARE COUNTY 2008 REPORT

The major thrust of the 2008 work plan of the MTFCDC has been to continue in bringing awareness of the harmful effects of tobacco use while emphasizing the benefits of a tobacco free lifestyle. In the process, one major emphasis has been in promoting clean indoor air policies for all work places and to promote cessation.

In scope, the overall mission of the MTFCDC is to help eliminate disparity in the ethnic minority population of Delaware County. We continue to work closely and in collaboration with the community based coalition through a comprehensive approach to tobacco education, prevention, counter marketing, youth advocacy, cessation and building diverse partnerships. As a specialized unit of the Health Department, we continue to develop meaningful programs and presentations throughout Delaware County. We are funded by Indiana Tobacco Prevention and Cessation (ITPC) while Future Choices Inc. serves as the lead/fiscal agent.

The coalition is made up of members and community partners representing the education, business, civic/community, health, faith based, youth, pregnant and women of child bearing years, minority males, and disparate populations of our community. There are also two adult allies to work with the local VOICE youth group, one of whom serves as our mascot "Count Tobaccula" The count's creed is 'the only thing that I want to suck in is clean air. 

Every month in 2008 a class was facilitated by one of the following: Ball Memorial Hospital- Family Medicine Residency, Delaware Co. Health Department, Cancer Services of Delaware County –Little Red Door, or Open Door /BMH Center. The coalition provides a number to the public (through our public health education campaign) for information on the cessation classes, services available and other information on tobacco use and prevention. The cessation subcommittee has met several times during the year and has changed the cessation schedule for 2009 to focus on individual cessation counseling and classes three times during the year.
- The TFCDC has improved collaborations during 2008 with organizations such as Ball Memorial Hospital's Cardiac Rehab department, BMH's Wellness Center and the Heart/Stroke Network. The coalition is also developing an initiative with TEAMwork for Quality Living's poverty initiative to include a cessation component for the program participants. The coalition has also been instrumental in the passing of the new smoking policy at Ball State University as well as the comprehensive tobacco-free policy at Ivy Tech's East Central Indiana campus sites.
