

ORDINANCE ESTABLISHING DELAWARE COUNTY SHERIFF'S JAG GRANT

DELAWARE COUNTY COMMISSIONERS

WHEREAS, the Delaware County Sheriff's Office has applied for and received a grant from the Bureau of Justice Assistance, US Department of Justice, to be used for paying overtime to currently employed law enforcement officers and necessary support personal to increase the number of hours worked by such personnel; and

WHEREAS, it is necessary to account for the use of said funds and to expend said funds for the proposed use for which they were granted. It is necessary that the Auditor of Delaware County be authorized to establish an account known as "The Delaware County Sheriff's 2018 J.A.G. Grant "2018-DJ-BX-0830"; and

WHEREAS, the grant award is in the amount of \$24,767.00 and the portion to the Delaware County Sheriff's is in the sum of \$11,145.00. The Commissioners find that the acceptance of said grant should be approved.

IT IS THEREFORE ORDAINED BY THE DELAWARE COUNTY COMMISSIONERS, that the Auditor shall establish a fund entitled 2018-J.A.G. Grant 2018-DJ-BX-0830 and shall issue a budget fund number with respect to those funds. Said funds shall be exempt from needing appropriation.
