WHEREAS, the Gounty Health Officer has determined that certain measures should be put into place to lessent the potential spread of the COVID-19 virus including the closing of some local businesses; and

 L. Other business necessary for continuation of healthcare;

 M. Cleaning, maintenance and janitorial services;

 N. Shipping and delivery services;

 N. Any business that maintains drive-through service may remain open;

 Q. All Veterinary Services may remain open;

 R. All Road;

 S. Telecommunications and Cellular Services may remain open, but with the public in the offices;

 T. Water Delivery services and its contractors;

 M. Melai;

 W. Energy Delivery and its contractors;

 W. Energy Delivery and its contractors;

 X. Only those organizations providing essential human and medical services such as the Muncle Mission, YWCA, Christian Ministries and the like may remain open subject to further order;

 X. Only those organizations providing essential human and medical services such as the Muncle Mission, YWCA, Christian Ministries and the like may remain open subject to further order;

 X. Other specific businesses as requested by DCHD, DCEMA, Delaware County Commissioners, and/or the Mayor of Muncle as being necessary to support critical operations as addressed in a letter of authorization by one of the authorities.

- 4. All county offices and buildings or facilities shall be closed except those related to emergency matters and to assist the Commissioners, Health Department, Delaware County Emergency Management Authority in their functions to maintain the continuity of government.
- 5. This emergency declaration shall be enacted and made effective as to all appropriate laws, statutes, ordinances, and resolutions and particularly to Indiana Code 10-14-3-29 until further order of the Executive of the City and/or the County.

- 6. - Any person, firm or entity found to be operating in violation of this order may be fined up to the sum of \$2,500 for each violation. Each and every day constitutes a separate violation.

The Board of Commissioners of Delaware County may implement stricter requirements in the future such as reducing work schedules, work at home rules, closing county facilities and non-emergency operations and other actions necessary to protect the employees and the general public from the spread received.

A RESOLUTION REQUIRING CERTAIN COUNTY CONTINUITY OF SERVICYES AND EMPLOYEES TO WORK REMOTELY DURING DECLARED EMERGENCY

| WHEREAS, | the President of the United States has declared a national emergency for the same; and |

| WHEREAS, | the Governor of Indiana has declared a public health emergency for Coronavirus Disease 2019 Outbreak ("COVID-19") pursuant to l.c. 10-14-3-12; and |
| WHEREAS, | it is imperative to allow certain county employees to work remotely in an effort to curtail the community spread of COVID-19; and |
| WHEREAS. | It is important for the continuity of services to the County, its vendors and employees; and |
| WHEREAS, | allowing certain employees to work remotely will further help promote the safety and well-being of both county employees and general public during the declared emergency; and |
| WHEREAS. | allowances need to be made for those employees whose position can not be performed remotely as to payment of salaries. |
| WHEREAS, | the Board of Commissioners that the following procedures shall be implemented effective March 23, 2020 until such time as the emergency from the COVID-19 virus has been lifted. |

NOW, THEREFORE, IT IS RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY that:

- The procedure for the approval of claims pursuant to I. C. 36-4-8-5 shall be waived in the event that a regular public
 meeting of the Board of Commissioners can not be convened and the President of the Board of Commissioners (if
 they are able and if they are not then the Vice President) shall review and approve all valid claims that would have
 otherwise been presented at the meeting.
- 2. The Commissioners have required some or all of the employees of the County to refrain from coming into the County Offices during the time of this national emergency as per I. C. 10-14-13-12 and for those employees that are directed to refrain from coming to work they shall continue to receive their regular pay and this pay shall be determined to be Said compensation shall be deemed to be "Emergency Stay Home Pay" and shall be limited to the employee's regular salary in the County salary ordinance without any overtime.
- Department heads and department supervisors shall implement a plan to allow essential county offices and departments to remain operational but to also allow certain county employees to work remotely until further notice.
- Those employees that work remotely shall receive pay (hourly and/or salaried) for their regularly scheduled nonovertime work hours subject to the conditions set forth as follows:

a. If some or all of the employee's job functions can be performed from home, the employee is expected to perform those job functions from home during the employee's regularly scheduled nonovertime work lours;

b. During the employee's regularly scheduled non-overtime work hours during the emergency, the employee is considered "on-call" and, therefore, must be available by phone to respond to calls from other County officials and must be available to return to their work station within two (2) hours of notice from their supervisor, Commissioners, or his/her designee.

- 5. For those employees that cannot work remotely, they shall be considered to be "on call" in the event that during the emergency their services are needed. Said employees including temporary, seasonal or part-time employees shall be paid for hours regularly worked.
- No employee may work or earn compensation from any other source during the employee's regularly scheduled non-overtime work hours (i.e., for which the employee would earn Emergency Stay Home Pay).
- 7. For those employees that are required to work remotely or to perform they shall receive their regular compensation as per the County salary ordinance unless they are required to perform services outside of the normal business hours of the county at which time they shall be compensated at the rate of one and half times their normal hourly rate and shall be entitled to be paid as compensatory time off for their efforts after the emergency declarations have been rescinded.
- Accruals for the benefit of calculations such as vacation pay, sick leave pay, holiday pay and seniority determinations shall continue to accrue during the public emergency closing.
- 8. Nothing in this Resolution shall amend or modify any collective bargaining agreement or interpretation therein.
- 9. Employees on vacation, FMLA or sick leave while the county offices are closed to both the public and employees shall be charged with their vacation, FMLA or sick leave and at the conclusion of their paid time off shall be eligible to receive their regular income during the course of the pandemic emergency closing. Employees on sick leave or FMLA leave shall submit a medical release from their medical provider to qualify for Emergency Stay Home Pay during the pandemic emergency closing.

This Supplemental Contract, is made and entered into effective as of the date of the Indiana Attorney General signature affixed to this Supplemental Contract, by and between the Indiana Deputtment of Transportation, (hereinafter referred to as "INDOT"), and <u>Delaware County</u> (hereinafter referred to as "LIPA").

WITNESSETH

WHEREAS, INDOT and the LPA did, on May 21, 2015, enter into a Contract, and did on April 17, 2017, enter into Amendment Number 1, providing for Services required in connection with INDOT Designation Number 9680560 for bridge #161 over White River on County Road 170 South, 1,8 miles south of State Road 32 and

WHEREAS, it has been determined by INDOT that an amendment of the previously executed INDOT/LPA Contract for Services is necessary due to a change in the Federal aid Project, and

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the LPA and INDOT agree as follows:

The "Recitals" above are hereby made an integral part of and specifically incorporated into this Contract <u>Amendment Number 2</u>.

Section V - TERM AND SCHEDULE of the original Contract is amended to read as follows:

SECTION V TERM AND SCHEDULE.

- A. If the LPA has the plans, special provisions, and cost estimate (list of pay items, quantities, and unit prices) for the Project ready such that federal funds can be obligated (INDOT obligates the funds about 7 weeks before the date bids are opened for the construction contract), between <u>July 1, 2020 and June 30, 2021</u>, INDOT will make the federal funds shown in section I.A. and/or I.B. of Attachment D available for the Project, provided the Project is eligible, and provided the federal funds shown in section I.B. of Attachment D are available.
- B. In the event that federal funds for the Project are not obligated during the time listed in section V.A., but the LPA has the plans, special provisions, and cost estimate for the Project rendy such that federal funds can be obligated between <u>July 1, 2021 and June 30, 2023.</u> INDOT will schedule the contract for letting, provided the Project is eligible, and provided the federal funds shown in section I.B of Attachment D are available.
- C. In the event that federal funds for the Project are not obligated during the period listed in section V.A. or section V.B., the federal funds allocated to the Project may be obligated in the fiscal year chosen by INDOT or the federal funds allocated to the Project will lapse.

President Henry said employees should wear masks as stated in the declaration. Department heads are responsible to keep employees 6 feet apart.

Disaster Emergency Declaration 2020-10

Delaware County, Indiana

- WHEREAS, the President of the United States, on March 13, 2020, has declared a nationwide emergency concerning the spread of COVID-19 viral infections, and
- WHEREAS, the Governor of the State of Indiana, on March 16, 2020, has made an emergency declaration in response to the Coronavirus (COVID-19) disease epidemic; and
- WHEREAS, the County Health Officer has determined that certain measures should be put into place to lessen the potential spread of the COVID-19 virus including the closing of some local businesses; and
- WHEREAS, pursuant to 1. C. 10-14-3-29(a) the Board of Commissioners of Delaware County, IN hereby makes a local disaster emergency declaration; and
- WHEREAS, the Governor has adopted Executive Orders 20-25 and 20-26 as map for continued protection from the COVID-19 threat as well as a map of reopening the State and County; and
- WHEREAS, the Board of Commissioners of Delaware County, Indiana have determined that in response to the emergency believes that the Governor's order should be made a part of the County's Emergency Declaration for consistency and continuity and that the Emergency Declaration of April 17, 2020 should be extended.

NOW THEREFORE WE, THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA HEREBY DECLARE THAT:

1. A local disaster emergency continues to exist in the County and that we hereby invoke and declare those portions of the Indiana Code which are applicable to the conditions and have caused the issuance of this proclamation, to be in full force and effect in the entire County, including incorporated areas for the exercise of all necessary emergency authority for protection of the lives and property of the people of this County and the restoration of local government with a minimum of interruption. This Emergency Order is effective immediately and shall be in place until the end of business May 18, 2020.

- The Board of Commissioners adopt the Governor's Executive Order 20-26 in whole as part of their emergency declaration and plan to return to get back on track.
- 3. The County government shall continue to operate, but commencing on May 11, 2020 the elected officials and department heads shall commence operation pursuant to the office holder's plan for scheduling and operations. Members of the public shall contact the office and make an appointment with the office before entering the County Building and Justice Center. All employees and members of the public that will meet in person shall maintain a social distance of at least 6 feet between individuals at all times and shall be required to wear a face mask or other covering which covers the person's mouth and nose during their of their business in the County Building. All county employees shall be required to wear a mask or face covering their nose and mouth when interacting with the public and when not at their desk.
- 4. Commencing on May 11, 2020 there shall be a limit of the number of members of the public that shall be permitted to access the County Building or Justice Center. No more than 25 members of the public per floor may be allowed to enter the County Building and occupy the building at any time. There shall be a limit of 25 people allowed in the Justice Center to conduct business, excluding staff, lawyers and litigants. Those members of the public that exceed the limit in either the Justice Center or County Building will be required to wait outside of the building following proper social distancing requirements of at least 6 feet intervals.
- The Governor's Executive Order 20-25 is incorporated by reference and made a part of this Emergency Declaration.

- 6. In instances where an individual must visit a retail business, the business shall follow the proper social distancing requirements in Executive Order 20-26 and the guidelines from the Center for Disease Control (CDC).
- All individuals are encouraged and should wear masks when going out to essential businesses, grocery stores or outside of their residence for any essential purpose.
- This Emergency Declaration shall supersede and replace all prior Emergency Declarations made the by Board of Commissioners prior to this Emergency Order.
- 9. The Commissioners determine that all government operations are essential as the government operations from March 23, 2020 to the present and all essential governmental functions are operating and available to the public through remote or electronic access, as needed.
- 10. Violations of this order will be turned over to the Governor's Enforcement Response Team as setforth in Executive Order 20-26 for investigation and enforcement.
- 11. This Emergency Order shall remain valid for a period of eleven (11) days from the date that this Emergency order was adopted by the Board of Commissioners.

SPONSORING HOSPITAL AGREEMENT

BETWEEN

ST. VINCENT ANDERSON AND

Delaware County Emergency Medical Service

THIS AGREEMENT is made this ____Day of __March, 2020, by and between ST. VINCENT ANDERSON HOSPITAL (hereinniter referred to as SPONSOR) and Delaware County Emergency Medical Service (hereinafter referred to as PROVIDER).

INTRODUCTION
In order to meet State requirements for the provision of advanced life support emergency medical services, the PROVIDER desires to contact with the Sponsor as a duly certified Sponsoring Hospital for the sponsorship of the PROVIDER as a Paramedic organization. It shall be the intent of this Agreement to coordinate the functions of the SPONSOR and the PROVIDER in the development and implementation of operational and continuing education and evaluation programs for paramedic activities carried out by paramedics employed by the PROVIDER. The responsibilities of the SPONSOR and the PROVIDER in providing advanced life support emergency medical services shall be delineated in the following.

Mr. Scott Alexander, Council President said he and Mr. Ed Carroll, Treasurer worked with New Castle, Indiana respresentatives regarding the Furlough Program that was offered to their employees.

President Henry said if 30 employees would take Furlough, it would save Delaware County approximately \$200,000.

Mr. Brooke will send Resolution to elected officials. Elected officials and department heads will determine who would/could be furloughed. The Commissioners will work with Human Resource Director, Ms. Pam McCammon, Director to determine seniority rights. Delaware County Furlough would start Mary 14 through August 5, 2020. Unemployment is available for Fulough.

A RESOLUTION CREATING A VOLUNTARY COUNTY FURLOUGH PROGRAM

| WHEREAS. | the President of the United States has declared a national emergency for the Covid-19 novel virus; and |

the Commissioners have worked with the County Council to create a furlough program for employees that volunteer to be furloughed for 12 weeks as a start to conserve the financial resources of the County. NOW, THEREFORE, IT IS RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY that:

WHEREAS

- The Board of Commissioners creates a "Voluntary County COVID-19 Furlough Program".

 Each of the Department Heads and Elected Officials will contact their staff and seek volunteers to be furloughed. The Department heads and Elected Officials will contact their staff and seek volunteers to be furloughed. The Department heads and Elected Officials will contact their staff and seek volunteers to be furloughed. The Department heads and Elected Officials will review all requests for furlough and shall send the approved employees to the Commissioners.

 An employee on FAMILIES FIRST leave under the CARES Act (either at 100% or 80% pay) shall be ineligible for furlough. An employee on FAMILIES FIRST leave under the CARES Act (either at 100% or 80% pay) shall be ineligible for furlough. The furlough program shall be limited to a number as determined by the Board of Commissioners, the Commissioners shall select the employees who have the most time of service to the County as being furloughed first. County employees (volunteers) will be furloughed for a period of 12 weeks starting May 14, 2020 until August 5, 2020. Furloughed employees will be eligible for unemployment benefits.

 The county will pay the county's share of their health insurance monthly costs. The Employee is required to pay the amount of the health insurance that is deducted from their regular pay to the County on a monthly basis. If an employee fails to pay their health insurance costs for more than 30 days their health insurance could be terminated.

 While on furlough, the employee will still continue to earn personal days and sick time while on furlough.

 Furloughed employees will be employee that thooses not to work will lose 1/gm of their name service time with PERF, An employee that chooses not to work will lose 1/gm of their name service to maintain their service time with PERF, then they simil be required to work one day per month in different pay periods to maintain their PERF shall have the Department Head and/or Elected official notify the County

- All compensatory time off shall be frozen until the employee returns to work.
 All compensatory time off shall be frozen until the employee returns to work.
 No employee on an extended leave, work compensation leave or other type of leave shall be eligible for furlough.
 All vacation time camed and not used as well as compensatory time off, personal days and sick days not used shall be frozen and eligible to be used by the employee once the employee returns to work.

16. At the end of the furlough period the County Commissioners will notify the employees when to return to work.
17. Any employee that does not report back to work on the date indicated by the County Commissioners shall be terminated pursuant to the County policy.
18. This Resolution shall expire on August 6, 2020.

RESOLUTION 2020-009

A RESOLUTION REQUIRING CERTAIN COUNTY CONTINUITY OF SERVICIVES AND EMPLOYEES TO WORK

WHEREAS, the President of the United States has declared a national emergency for the same; and WHEREAS. the Governor of Indiana has declared a public health emergency for Coronavirus Disease 2019 Outbreak ("COVID-19") pursuant to l.c. 10-14-3-12; and allowing certain employees to work in shifts and to work remotely to help continue to promote the safety and well-being of both county employees and general public during the declared emergency; and WHEREAS. WHEREAS. allowances need to be made for those employees whose position can not be performed remotely as to payment of salaries; and the Governor of the State of Indiana has implemented a process for getting Indiana back to work and government operating to serve the citizens; and WHEREAS.

WHEREAS

the Commissioners have adopted Executive Orders 20-25 and 20-26 as part of their plan to return County Government and businesses back to pre-emergency basis.

NOW, THEREFORE, IT IS RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY that:

- The Commissioners have required some or all of the employees of the County to work on staggered work days and shifts as per directions from the Elected Officials and Department Heads during the time of this national emergency as per I. C. 10-14-13-12 to allow limited number of employees to work at the County offices and maintain social distancing requirements and allow to for those employees that have the ability and work to work from home.
- The County also will adopt a voluntary furlough program for employees to be furloughed from work and qualify for unemployment.
- Those employees that not furloughed and at time not working in the County offices shall also work from home or are directed to refrain from coming to work shall continue to receive their regular pay and this pay shall be determined to be said compensation shall be deemed to be "finerpey Stay Home Pay" and shall be limited to the employee's regular salary in the County salary ordinance without any overtime.
- Those employees that work at the County offices and/or remotely shall receive pay (hourly and/or salaried) for their regularly scheduled non-overtime work hours subject to the conditions set forth as follows:
 - a. If some or all of the employee's job functions can be performed from home, the employee is expected to perform those job functions from home during the employee's regularly scheduled non-overtime work hours;
 - b. During the employee's regularly scheduled non-overtime work hours during the emergency and they are not working in the County offices, the employee is considered "on-call" and, therefore, must be available by phone to respond to calls from other County officials and must be available to return to their work station within two (2) hours of notice from their supervisor, Commissioners, or his/her designee;

- 5. For those employees that cannot work remotely, they shall be considered to be "on call" in the event that during the emergency their services are needed. Said employees including temporary, seasonal or part-time employees shall be paid for hours regularly worked.
- 6. No employee may work or earn compensation from any other source during the employee's regularly scheduled non-overtime work hours (i.e., for which the employee would carn Emergency Stay Home Pay).
- 7. For those employees that are required to work remotely or to perform they shall receive their regular compensation as per the County salary ordinance unless they are required to perform services outside of the normal business hours of the county at which time they shall be compensated at the rate of one and half times their normal bourly rate and shall be entitled to be paid as compensatory time off for their efforts after the emergency declarations have been reschieded.
- Accounts for the benefit of calculations such as vacation pay, sick leave pay, holiday pay and seniority determinations shall continue to accord during the public emergency.
- 8. Nothing in this Resolution shall amend or modify any collective bargaining agreement or interpretation therein.
- 9. Employees on vacation, FMLA or sick leave while the county offices are on a staggered shift basis shall be charged with their vacation, FMLA or sick leave and at the conclusion of their paid time off shall be eligible to receive their regular income during the course of the pandemic emergency closing. Employees on sick leave or FMLA leave shall submit a medical release from their medical provider to qualify for Emergency Stay Home Pay during the pandemic emergency closing.
- 10. Employees on CARES Act Families First leave shall continue said leave for their 80 hours of work and may extend this leave pursuant to PMLA leave, if applicable, utilizing the County's policy as to vacation, sick, personal and comp time usage for payment.
