### FOURTH REVISED ECONOMIC DEVELOPMENT INCOME TAX CAPITAL IMPROVEMENT PLAN OF DELAWARE COUNTY JULY 1, 2019 THROUGH JUNE 30, 2022

INTRODUCTION:
This Plan is intended for adoption by the Board of Commissioners of Delaware County in conformance with Ind. Code § 6-3.5-7-1 et seq. It is intended to create the Commissioners' three-year plan from July 1, 2019 through June 30, 2022. This Plan will cover only the projects for which distributions have been certified. This Plan should not be considered as final approval for expenditures on any of these specific projects. The timing of performance of each project and final approval of release of funds must be obtained by specific application to the Delaware County Board of Commissioners.

STATUS OF CAPITAL PROJECTS UNDER ORIGINAL PLAN:
Certain Capital Projects described in the Commissioners prior plans have been completed.

#### **BOND ISSUES:**

Under existing bond issues, EDIT revenues are committed at the annual amount of approximately \$978,000.00, payable in June and December of each year at the rate of approximately \$489,000.00 per payment. In addition, there is one final payment in the amount of \$30,600.00 due in December, 2013, to pay off the 2004 bond issue.

#### PROJECTS:

Project 1 -**Bond Issues**

Description of Project: This project concerns the payment of obligations incurred over the course of time for bonds and projects prior to July 1, 2019. 2013 Bond for various projects payable semi-annually at amounts set forth in the schedule and 2014 Bond for various projects payable semi-annually at amounts set forth in the schedule. The 2013 Bond will be retired at the end of 2020.

Project 2 -**Delaware County Justice Center and Jail**

Description of Project: The renovation and construction of a new justice center Courthouse and jail complex at 3100 S. Tillotson, Muncie, IN 47302, payments for which are scheduled to begin in July

Project 3 -**Delaware County Redevelopment Commission**  \$225,000,00 for 2019 \$400,000.00 for 2020

Description of Project: Annual payment to the Delaware County Redevelopment Commission for operating expenses, salaries and other expenses of the Commission that are not reimbursable from Redevelopment projects/funds

#### Project 4 - Economic Development:

Description of Project: Economic incentive funds for economic development projects and expenses related thereto. This also will include airport tower operations and ECI/RD costs.

Description of Project: Assistance provided to the Town of Albany for maintenance and upgrades to the Town's sidewalk infrastructure.

#### Project 6 - Town of Yorktown:

Description of Project: Assistance provided to the Town of Yorktown for its downtown redevelopment project, which will take place during the term of the Plan.

Description of Project: Assistance provided to the Town of Eaton for maintenance and upgrades to the Town's sidewalk infrastructure and for maintenance and upgrades to the Town's water system. Assist the Town with their local match funds for water project.

Project Description: Attorney fees related to the creation, amendment and maintenance of the EDIT plan on an annual basis.

Project Description: The COVID-19 pandemic has caused a significant increase in the need for public safety and public health issues. The State of Indiana has received a grant from the federal government to help fund some of these expenses, but there is reliance on local government to also locate and fund COVID-19 related expenses for public safety and public health.

SEVENTY-FIVE PERCENT (75%) TEST: In accordance with Ind. Code § 6-3.5-7-15, this Plan incorporates projects, the costs of which when taking into consideration funds already pledged for repayment of obligations from prior Projects, are at least seventy-five (75%) of the certified distribution the County expects to receive during the term of the Plan.

WHEREAS the State of Indiana, through its Indiana Finance Authority, the ability to review requests for funds and approve the grant like funding of projects, equipment, inventory, supplies and other items that are or will be incurred by Delaware County related to dealing with the pandemic; and

WHEREAS, it is necessary to establish a fund in the Auditor's Office into which the proceeds will be deposited and from which expenditures will be disbursed.

#### NOW, THEREFORE, BE IT ORDAINED that:

- the Auditor shall establish a fund entitled Delaware County CARES Act Response Gran and said Auditor has issued a budget fund number of

### DELAWARE COUNTY COMMISSIONERS RESOLUTION APPROVING AMENDMENT TO THE COUNTY PERSONNEL HANDBOOK

WHEREAS, the Board of Commissioners of Delaware County have adopted a County Personnel handbook for the conduct of employees in the workplace;

WHEREAS, the Delaware County Commissioners believe that the County Personnel Handbook should be amended from time to time;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA:

- 1. The Delaware County Personnel Handbook shall be amended as follows:
  - A. Add a new section:

### 1.2 Equal Treatment of All People

The Board of Commissioners of Delaware County have adopted Resolution 2020-30 which asserts the requirement that all County employees, personnel, Vendors and contractors are to conduct their business without decisions or policies based upon race, gender, religion, sexual orientation or national origin in all aspects of County business and decisions

Any employee, Vendor, contractor or sub-contractor that fails to abide by this requirement shall be reported to the County's HR Department immediately along with a description of the acts alleged to have occurred. The County HR department shall immediately commence an investigation as to the allegations. All County employees, contractors, Vendors and sub-contractors shall be required to participate fully and completely in the investigation. Any reluctance or failure to cooperate in the investigation shall be reasons for discharge, cancelation of contract or rescission of any agreement conducting business with the County.

B. Add a new section in Group II offense for discipline of an employee for the following conduct:

- 28. Any action, conduct, decision or event that exhibits any treatment of any employee, member of the public, contractor, contractor's employees or any other person that disparages a person based upon their race, gender, sexual orientation, religion or national origin in any way.
- 2. This resolution shall be effective upon passage.

### A RESOLUTION OF THE DELAWARE COUNTY, INDIANA BOARD OF COMMISSIONERS IDENTIFYING TAX SALE CERTIFICATES TO BE ASSIGNED TO NONPROFIT ENTITIES PURSUANT TO IND. CODE § 6-1.1-24-6.7

WHEREAS, Ind. Code § 6-1.1-24-6.7 sets out the procedures the Board of Commissioners may utilize to assign tax sale certificates to a nonprofit entity;

WHEREAS, the Board of Commissioners has identified the parcels of real property identified on Exhibit A, attached hereto, for which the Board of Commissioners currently hold tax sale certificates, has been in one or more tax sales, and has taxes which remain severely delinquent;

WHEREAS, the Board of Commissioners now desires to assign the tax sale certificate for the above-referenced properties to nonprofit entities for use for the public good;

WHEREAS, the Board of Commissioners intends to accept written applications from eligible nonprofit entities that satisfy the requirements of Ind. Code § 6-1.1-24-6.7 and desire to have the tax sale certificate for the identified properties assigned to them; and

WHEREAS, the Board of Commissioners will conduct a public hearing to consider all submitted applications and hear any opposition to the proposed assignments.

IT IS THEREFORE RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA THAT:

<u>SECTION 1</u>. The Board of Commissioners hereby identifies the properties identified on <u>Exhibit A</u>, attached hereto, as those for which the Board of Commissioners hold tax sale certificates and now desires to assign said certificates to nonprofit entities for use for the public good.

SECTION 2. The Board of Commissioners will conduct a public hearing to consider the assignment of the tax sale certificates to eligible nonprofit entities and said public hearing shall occur on the 5th day of October, 2020, at 9:00 a.m. in the Delaware County Commissioner's Courtroom, Room 309, 100 West Main Street, Muncie, Indiana 47305.

SECTION 3. The Board of Commissioners shall cause to be published a notice regarding the public hearing and, prior to said public hearing, will accept written applications that are in compliance with the requirements of Ind. Code § 6-1.1-24-6.7(h) from eligible nonprofit entities that desire to have the tax sale certificates for the identified properties assigned to them and consider said applications prior to making a final determination concerning the assignment of the tax sale certificates.

Commissioner King said during the recent forum in which Commissioner Riggin participated in, conversation took place about drug rehab.

Commissioner King said he along with Mr. Tony Skinner, Sheriff of Delaware County, visited a clinic in Nashville, TN. Mr. Brooke is currently working with the attorney of the Nashville facility, this type of facility will be available at the new jail. A build out is currently being worked on. The Commissioners are going to do what they promised they would do.

Once an officer brings someone in, it will then be determined to place him/her into the mental/drug rehab facility or jail. Councilors will be available 24/7.

The Commissioners are working with a company that is doing a study to determine the best purpose for ground located by the new jail. Once the proposal comes in, the Commissioners will work with City of Muncie to determine the best fit for the community. The land will be tax dollars to the city. If it is turned into a TIF district, money will be used to pave roads, rebuild bridges, and bring manufacturing into Delaware County to raise the tax base. This will not be placed onto the taxpayers.

Mr. Skinner said the company running the mental health facility is a spin-off of medical company that provides services to the jail (Quality Corrections Care). The mental health company is Q-360. This is the same owner as Quality Corrections Care and is non-profit. Skinner said the facility is Nashville, TN is the first one in the country and Delaware County will be the second and first in Indiana. Mr. Skinner provided details to the Governor's staff.

Once this is up and running and is successful, Mr. Skinner sees other facilities coming to the State. The vision is if the person fits the criteria, they go to rehab or mental health then the charges would go away. This would be a diversion, they either successfully complete the mental part and charges would be expunged or charges would be reinstated and they would be placed back in jail. This is completely voluntary. There is plenty of people in the criminal justice system that needs this help. There will be 20 beds for women and 20 beds for men.

Commissioner Riggin mentioned a CIT training program for the First Responders.

Mr. Brooke said he responded to two questions asked by the public through Facebook.
