WHEREAS, having received from Co-Alliance Cooperative, Inc., an Indiana agricultural cooperative, a petition to vacate certain rights-of-way, the Board of Commissioners of Delaware County, Indiana, has provided notice, pursuant to Ind. Code § 36-7-3-12(e) and Ind. Code § 5-3-1 stating that it now desires to vacate a certain public right-of-way located within Delaware County, Indiana, as illustrated in "EXHIBIT A" attached hereto (the "Vacation Area"), which said Vacation Area is generally described as follows:

WHEREAS, the Delaware County Board of Commissioners, as the legislative body and executive of Delaware County, Indiana (hereinafter, the "Commissioners"), owns certain real property located in the Town of Eaton, Indiana, which is specifically identified on EXHIBIT A, attached hereto (hereinafter, the "County Property");

WHEREAS, the Town of Eaton, Indiana (hereinafter, the "Town"), desires to acquire the County Property from the Commissioners to be used to provide for, and improve, the health and general welfare of the Town's residents and visitors; and

WHEREAS, the Commissioners desire to transfer said County Property to the Town, subject to acceptance of said County Property by the Town as evidenced by the adoption of a substantially similar resolution by the Town's Town Council and upon the various terms and conditions as stated herein.

### NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA THAT:

- The Delaware County Board of Commissioners shall transfer said County Property, as
  described in <u>EXHIBIT A</u>, attached hereto, to the Town of Eaton, Indiana, upon acceptance
  of the County Property by the Town and upon the Town's payment in the sum of Six
  Hundred and 00/100 Dollars (\$600.00) to Delaware County as reimbursement of the
  County's acquisition costs for the Property, as well as payment of any required transfer
  and/or recording fees.
- The Town's acceptance of the County Property shall be demonstrated by the adoption of a
  substantially similar resolution by the Town's Town Council, a copy of which shall be
  provided to the Commissioners upon its adoption by the Town's Town Council and
  maintained in the Commissioners' records.
- 3. The Delaware County Auditor shall provide an executed copy of this Resolution to the Town and, upon receipt of a substantially similar resolution adopted by the Town's Town Council, the President of the Board of Commissioners shall be authorized to execute all necessary documents to facilitate and carry out said transfer of the County Property to the Town.

WHEREAS, the Delaware County Redevelopment Commission ("Commission"), on May 13, 2021, approved and adopted Resolution 2021-002A entitled "Resolution of the Delaware County Redevelopment Commission Approving an Amendment to the Declaratory Resolution and Amended and Restated Economic Development Plan for the Industria Centre Economic Development Area" (the "Declaratory Resolution") pursuant to IC 36-7-14, and subsequently confirmed the Declaratory Resolution on June 24, 2021 after conducting a duly noticed public hearing; and

WHEREAS, IC 36-7-14-41(c) requires that the determination that a geographic area is an economic development area be approved by the Board of Commissioners of Delaware County, Indiana (the "County Commissioners"), as the executive and legislative body of Delaware County, Indiana; and

WHEREAS, the County Commissioners reviewed the Declaratory Resolution as confirmed by the Commission, the Commission's Economic Development Plan approved pursuant to the Declaratory Resolution, and the written order of the Delaware-Muncie Metropolitan Plan Commission regarding the Declaratory Resolution and the Economic Development Plan, and now desire to make the determination that the geographic area described therein is an economic development area.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA THAT:

- The County Commissioners hereby find and determine that it will be in the best interests
  of Delaware County to amend the Industria Centre Economic Development Area as
  described in the Declaratory Resolution as confirmed by the Commission.
- The reestablishment of an Economic Development area in the area known as the Industria Centre Economic Development Area as described in the Declaratory Resolution and in Exhibit A to the Declaratory Resolution is hereby approved.

The State has allocated \$500 million to promote investments within the State of Indiana. This will be appropriated to 92 counties within the State of Indiana. ## A RESOLUTION IDENTIFYING A REGION FOR THE CREATION OF A REGIONAL DEVELOPMENT PLAN (RDP) AND PARTICIPATION IN THE INDIANA REGIONAL ECONOMIC ACCELERATION AND DEVELOPMENT INITIATIVE (READI)

WHEREAS, the state of Indiana, through its Indiana Economic Development Corporation (IEDC) launched the Regional Economic Acceleration and Development Initiative (READI); and

WHEREAS, House Enrolled Act No. 1001, of the 2021 Session of the Indiana General Assembly provided \$500 million in state appropriations to promote strategic investments that will make Indiana a magnet for talent and economic growth; and

WHEREAS, the READI program guidelines call for Indiana communities (counties, cities and towns) to identify their regions, coordinating organization and notify the IEDC by July 1, 2021 of their intent to seek implementation funding up to \$50 million for each region; and

WHEREAS, the IEDC will make available up to \$50,000 for a planning grant to assist in the creation of a Regional Development Plan (RDP) for submission to the IEDC by August 31, 2021; and

WHEREAS, both the planning and implementation phases of READI require matching funds from the private sector and local community; and

WHEREAS, the READI program guidelines discourage more than one RDP from the same region and the guidelines state, "overlap between regions could indicate a lack of regional collaboration;" and

WHEREAS, support from local government elected officials of the East Central Indiana Regional Partnership area (www.forgeeci.com) are important in the creation of the RDP and critical for its subsequent execution; and

WHEREAS, the East Central Indiana 21" Century Talent Region Designation's application, data and relationships will provide the framework for the creation of the RDP; and

NOW THEREFORE, BE IT RESOLVED, the undersigned

OMMISSIONES (Commissioners, County Council, City or Town
Council) determine that Delaware County (County, City or Town) shall join the East
Central Indiana Forge Your Path READI Regional effort as described herein.
